Clinical Research Center Fee Structure

The Clinical Research Center (CRC) offers a wide variety of Clinical Research Services throughout the life cycle of a clinical trial. The services can be utilized in an a la carte or bundled manner to meet the needs of each unique study. The following sections provide an overview of the fees associate with the services provided by the CRC.

Definitions

Funded Studies

Refers to clinical research adequately funded by either a grant or contract to cover all costs associated with the performance of the clinical research.

Underfunded Studies

Refers to clinical research that receives funding by grant or contract but is insufficient to cover all costs associated with the performance of the clinical research. Institutional support may be required in the form of fee reductions, clinical research development fund, etc.

Unfunded Studies

Refers to clinical research that has no funding source for study related activities and costs. Institutional support will be required in the form of fee waivers, clinical research development fund, etc.

Fee Waiver

Fee waivers are reviewed at two years and every year thereafter; may also be reviewed with amendments. If no accruals occur in the first two years a discounted maintenance fee will be implemented, or the study will be transitioned back to the department for regulatory oversight. Can receive a full fee waiver or a reduced fee waiver (reduced fee is discounted 75%). Amount of studies receiving full fee waiver may be restricted to an annual amount or study volume. Fee waivers to be reviewed by CRC Administrator; requests must be submitted prior to regulatory work being performed.

Fee Reduction

Reduced fees will be discounted at 75% of the full CRC rate. Reviewed at two years and every year thereafter; may also be reviewed with amendments. Fee reductions to be reviewed by CRC Administrator.

Annual Fee Structure Review

CRC Fee structure will be reviewed annually prior to UNMC/NM budget submissions for the next FY. Changes to the CRC fee structure will be communicated prior to implementation.

 Changes to the CRC fee structure will only be applied to new studies (not retroactive)

Please note that the fees listed are for services performed by the Clinical Research Center and may be separate from budget negotiations that may occur with a study sponsor.

Coverage Analysis & Budget Negotiations Tiers

The Clinical Research Center has the following tiered service offering for clinical research Coverage Analysis and Budget Negotiation.

Silver

 Current level of Clinical Trials Analyst (CTA) support delivered by the Clinical Research Center. New submissions are queued for coverage analysis and budget negotiation in the order they are received.

Gold

— \$4,000 per study; an individual study request submitted to study intake for prioritization of CTA support of new trials requiring coverage analysis and/or budget negotiation and is inclusive of any future amendment coverage analysis and budget renegotiation. The request can only be made at the individual investigator level (not a division); the fee must be paid up front and cannot be negotiated into a study budget.

Platinum

— An individual investigator (not a Department/Division) can support up to 0.5 FTE per annum for immediate CTA support of new trials requiring coverage analysis and/or budget negotiation and is inclusive of any future amendment coverage analysis and budget renegotiation. The salary support must be done at the individual investigator level (not a division) and will require a Memorandum of Understanding (MOU) be executed between both parties.

Gold and Platinum service levels are offered at the individual investigator level, not at the department/division level. All fees for the Gold and Platinum levels are paid at the investigator level and cannot be negotiated into a study budget.

CRC Clinical Billing to Department

- Supplies for services are included in the pricing if carried as normal stock in the Clinical Research Unit; specialty supplies will be ordered & charged to the research study account.
- These prices are subject to increases with prior notice.

CRC Study Invoicing Support

CRC Hourly Rate

\$30.00 PER HOUR

Hourly rate will apply to all tasks associated with study financials and will be billed monthly to the division. Rate will be waived for studies that are CRC coordinated.

Examples of study financial tasks are:

- Invoice creation
- Payment reconciliation
- Subject stipend and/or travel reimbursement processing
- CTMS budget entry
- Multi-site IIT payments to sub-sites

Tracking & Reporting

STUDY RELATED ACTIVITIES

Study effort will be tracked at the individual study level utilizing the "Effort Tracking" module in CTMS. The financial contact will log the total hours worked on a specific date for each study. Reporting will be performed monthly and the effort hours per study will be converted to a fee per study using the current CRC hourly rate. The fees will then be captured in the monthly invoice that is generated by the CRC staff and submitted to the department for review and approval. Study financial reporting will be provided to department leadership guarterly.
