

Jeffrey P. Gold, MD, is a nationally recognized leader and tireless advocate for transforming higher education, academic medicine and health care delivery across the public and private higher education spectrum.

He became the eighth chancellor of the University of Nebraska Medical Center, vice president of the University of Nebraska System and chair of the board of UNMC's principal clinical care academic health system partner, Nebraska Medicine, in early 2014.

In July 2021, Dr. Gold also was named provost and executive vice president of the University of Nebraska System, in addition to his ongoing UNMC/Nebraska Medicine responsibilities. In this role, Dr. Gold is the chief academic officer of the University of Nebraska System of approximately 50,000 learners, over \$750 million of research and liaison to the Board of Regents for all aspects of academic affairs.

As UNMC's chief executive officer, Dr. Gold is responsible for all aspects of campus leadership, program quality and operations, including seven colleges, two degree-granting institutes, the entire professional staff and faculty of more than 6,000 and 4,700 health professions students. Additionally, Nebraska Medicine has more than 8,500 employees and an operating budget of more than \$2.3 billion.

The combined annual economic impact of the "500-mile campus" academic health center with 37 Centers of Excellence exceeds \$6.4 billion and employs more than 52,000. During this time, the UNMC enrollment has grown by just more than 43%, the sponsored research programs by more than 300% and the clinical programs by more than 150%.

In his systemwide roles as provost and executive vice president, Dr. Gold oversees all undergraduate, graduate and professional academic education, research and experiential programs as well as the student support areas for the University of Nebraska system campuses, approximately 50,000 students, more than \$750 million in research and a combined economic impact of over \$10 billion.

From May 2017 to June 2021, Dr. Gold also served as chancellor of the University of Nebraska Omaha, the state's only public metropolitan university and its most diverse campus. The UNO complex has seven thriving colleges, an enrollment of more than 13,000 undergraduate students, 3,000 graduate students, a broad public service mission and two NCAA Division I-A athletic programs. Following more than four highly successful years of growth and prominence at UNO, in 2021, he stepped down to assume the University of Nebraska System provost and executive vice president responsibilities across all undergraduate, graduate and professional programs.

Dr. Gold holds a tenured faculty appointment at the rank of professor in the UNMC College of Medicine, as well as in the UNMC College of Public Health, where his active research interests in health care policy, population health and epidemiology are concentrated. He also leads several key economic development boards for the state and the university system, including the Greater Omaha Chamber, University Technology Development Corp, the University Technology Transfer Corp, Nebraska Enterprises Corp, UNeTecH Corp, and several others.

Prior to joining UNMC, Dr. Gold served as chancellor of the University of Toledo's academic and clinical health sciences, which includes the colleges of Medicine, Nursing, Pharmacy, Health Science and Human Service, and Graduate Studies. In that role, Dr. Gold had full leadership responsibility of the clinical, education and research programs, the faculty practice plan and the integrated hospital and ambulatory health care delivery system.

H. Dele Davies, MD, is an internationally recognized expert in pediatric infectious diseases and a leader in community health. As senior vice chancellor for academic affairs and dean for graduate studies, Dr. Davies is responsible for academic, faculty and student oversight of the six different health professions colleges and the graduate studies program, working with a talented team of deans, faculty and staff to build and enhance UNMC's academic programs and build the momentum of making UNMC the most learner-centered health science center in the nation.

Dr. Davies holds a master's degree in epidemiology from the University of Toronto, Canada, and a master's in health care management from the Harvard School of Public Health. He is specialty trained in pediatrics and pediatric infectious diseases from the Hospital for Sick Children in Toronto. He previously served as chair of pediatrics and human development at Michigan State University (2003-2012) and director of the Child Health Research Unit at Alberta Children's Hospital in Calgary, Canada, and the Child Health Research Institute at the University of Calgary (1993-2003).

Dr. Davies has more than 200 publications in peer-reviewed journals related to his research on infectious diseases topics, in addition to an edited book on Obesity in Childhood and Adolescence, several book chapters and other scholarly publications, and numerous presentations at national and international meetings.

His research interests lie in infectious diseases, especially perinatal infections caused by Group A and B streptococcus. His work was seminal in establishing the population-based rates, epidemiologic risk factors, serotypes and major virulence factors for Group A and B streptococcal infections in Canada, setting the stage for possible introduction of effective vaccines. His research has been funded by several agencies, including the National Institutes of Health, the Alberta Heritage Foundation for Medical Research and the Canadian Institutes of Health Research.

Dr. Davies is currently a member of the National Biodefense Science Board, providing guidance to the Secretary of the US Department of Health and Humans Services and the Assistant Secretary of Preparedness and Response within the Administration for Strategic Preparedness and Response, cochairing its Readiness and Resiliency Working Group. He also is a board member of the American Academy of Pediatrics Committee on Children and Disasters. He serves on the Dean's Advisory board of the University of Global Health Equity in Rwanda and on the Board of Directors of the Council of Graduate Schools.

Other previous national service includes a six-year term on the "Red Book" Committee on Infectious Diseases of the American Academy of Pediatrics; a five-year term as a member of the Board of Scientific Counselors for the National Centers for Infectious Diseases of the Centers for Disease Control and Prevention (Atlanta); a six-year term on the NIH (NIAID) Microbiology and Infectious Diseases (MIDB) Study Section on training grants; secretary-treasurer of the Association of Medical School Pediatric Department Chairs; chair of the Pediatric Investigators Collaborative Network on Infections in Canada; member of the Canadian Pediatric Society Infectious Diseases and Immunization Committee; member of Health Canada's Committee to Advise on Tropical Medicine and Travel; and chair of the Diversity Committee of the Council of Graduate Schools. He also is the founding past chair of the Association of Academic Health Centers Chief Academic Officers Executive Leadership Group.

Dr. Davies has received numerous prestigious awards during his career for his research, teaching, and mentorship, including the Mo-Watanabe Distinguished Faculty Award at the University of Calgary (twice), the William B. Weil Jr. Endowed Distinguished Pediatric Faculty Award of the College of Human Medicine at Michigan State University and the 2022 Deans Alumni Lifetime Achievement International Impact Award of the Temerty Faculty Medicine, University of Toronto. He is the namesake and honorary board member of the Davies Project that provides transportation for seriously ill children and pregnant women to essential healthcare. Since 2006, he has been recognized annually as a member of the Best Doctors of America, is a fellow of both the Infectious Diseases Society of America and Pediatric Infectious Diseases Society, and a member of the Alpha Omega Alpha National Honors Society, the Society for Pediatric Research, and the American Pediatric Society.

Bartholomew joined the health care system in 2003. She previously served in several roles within the Facilities and Process Improvement departments, including executive director of Facilities Management.







- Primary care clinic expansion efforts, including new facilities in community locations including downtown Omaha, North Omaha, Gretna, Elkhorn, Millard and Village Pointe.



Lt. Col. Elizabeth Schnaubelt, MD, joined the UNMC/Nebraska Medicine team in 2018 when she was assigned as the inaugural medical director for the U.S. Air Force Center for Sustainment of Trauma Readiness Skills (C-STARS) Omaha. C-STARS Omaha's mission is to advance the readiness skills and competency of U.S. Air Force medical personnel so they can provide safe and effective care for patients who have contracted or may have been exposed to highly hazardous infectious diseases. To accomplish the C-STARS Omaha mission, Dr. Schnaubelt and her team also work closely with the Nebraska

Biocontainment Unit. In addition to her significant responsibilities as the C-STARS Omaha medical director, Dr. Schnaubelt carries a substantial clinical load, attending on the general infectious diseases and orthopedic infectious diseases services in the UNMC ID Division, and fully participates in the clinical and educational missions of UNMC.




Figure 1. Number of clinical trial sites per 10,000 persons (2002–2007), by 3-digit zip code tabulation area. Circles are proportional to the number of clinical trial sites per 10,000 persons and are plotted at the centroid (spatial center) of each 3-digit zip code tabulation area. Data are based on 174,503 trial sites in the continental USA reported from 1 November, 2002 to 1 November, 2007 in the Bioresearch Monitoring Information System.

Kenneth Bayles, PhD, was named UNMC's Vice Chancellor for Research in 2022.

Dr. Bayles trained in bacterial genetics at Kansas State University, earning a PhD in 1989 for his studies of toxin production by the gram-positive pathogen, *Staphylococcus aureus*. He then performed post-doctoral research at the University of Maryland, Baltimore County, examining the regulatory response to DNA damage in *Bacillus subtilis* and *S. aureus*.

After nine years as a faculty member at the University of Idaho, he moved to the University of Nebraska Medical Center, where he became the founding director of the Center for Staphylococcal Research and combined the talents of several investigators to focus on the role of staphylococcal biofilm in the development of disease.

In 2011, Dr. Bayles was promoted to associate vice chancellor for basic science research, supporting several campus-wide efforts to enhance the productivity of its research faculty, including the Nebraska Drug Discovery and Development Pipeline. In 2018, he also was appointed associate vice chancellor for research and creative activity at the University of Nebraska Omaha.

Throughout his career, Dr. Bayles' research interests have been funded by multiple NIH grants and have remained focused on elucidating the regulation of bacterial cell death and defining their roles in biofilm development. This research has led to greater than 120 publications, many of which having expanded the boundaries of bacterial physiology to include the concept of bacterial programmed cell death and the hypothesis that the molecular control of this process is conserved in plants and animals. In addition, his studies have led to the discovery that bacterial biofilm is a complex developmental process that includes many functions previously thought to be reserved for more complex organisms.

In more recent years, his research interests have expanded to Department of Defense-related activities including work on countermeasures against weapons of mass destruction such as therapeutics and vaccines to protect against select agents and toxins, as well as compounds to protect against radiation exposure.

For his contributions to the field of microbiology, Dr. Bayles was inducted into the American Academy of Microbiology in 2017.

Upon earning his bachelor's of science degree in physical therapy from UNMC, Dr. Meyer began his career – that now spans over four decades – as a physical therapist. He practiced pediatric physical therapy for over 20 years and was instrumental in developing the first pediatric physical therapy department at Children's Hospital & Medical Center in Omaha.

He returned to his alma mater in 1991 as a faculty member and director of clinical education in the physical therapy program. During his tenure on faculty, he served on the UNMC Faculty Senate for seven years, presiding as president in 2000-01.

Dr. Meyer served as a credentialed clinical trainer for the American Physical Therapy Association Clinical Instructor Education and Credentialing Program and the Advanced Credentialed Clinical Instructor Program for 12 years. He was a member and chair of the national Clinical Instructor Education Board for the American Physical Therapy Association and co-authored a national training curriculum for physical therapy clinical educators, the Advanced Credential Clinical Instructor Program.

He later was appointed associate dean and then senior associate dean for Allied Health in the College of Medicine, prior to being named the founding dean of the newly created UNMC College of Allied Health Professions in 2015.





Gerard "Gerry" Kugel, DMD, PhD, began serving as dean of the UNMC College of Dentistry on Sept. 18, 2023.

He previously served as associate dean for research and professor of comprehensive care at Tufts University School of Dental Medicine in Boston, maintains a private dental practice and has helped develop a curriculum for a new dental school. He has extensive expertise in clinical research and esthetic dentistry.

Among his professional activities, Dr. Kugel serves as a reviewer for The New England Journal of Medicine, The Journal of Dental Materials, The Journal of Esthetic and Restorative Dentistry and The Journal of Cosmetic Dentistry. He also is a fellow in the Academy of General Dentistry and the Academy of Dental Materials.

Dr. Kugel received his doctorate of dental medicine from Tufts University in 1985 and his PhD in Dental Materials in 2004 from the University of Siena, Italy. He also has a master's degree in anatomy and cellular biology from Tufts, and an Executive Certificate in Management and Leadership from the Sloan School of Management at MIT. 





Bradley Britigan, MD, is a physician scientist trained in internal medicine and infectious disease. He has served as the Stokes-Shackleford professor and dean of the UNMC College of Medicine since July 2011.

Since 2011, Dr. Britigan also has co-directed the pediatric faculty practice plan, Children's Specialty Physicians, with the chief executive of Children's Hospital & Medical Center in Omaha.

In January 2014, he also assumed the role of interim president of Nebraska Medicine, the health care system formed by the integration of the Nebraska

Medical Center, Bellevue Medical Center, and UNMC-Physicians, whose formation he helped develop. The latter is the faculty practice plan of UNMC. He held this position until August 2016, when the health system named a permanent chief executive.

During Dr. Britigan's tenure as dean, the College of Medicine has seen a marked increase in the size and scale of activities in each of its missions. The number of full-time faculty has increased by 50 percent, extramural research funding has doubled, three new departments have been created, a new medical school curriculum has been developed and implemented, many new clinical programs have been developed in conjunction with the college's health partners, and the number of female leaders in the college has substantially increased.

A Minnesota native who grew up in St. Louis, Dr. Britigan earned his bachelor's degree at Cornell University in Ithaca, New York, and his medical degree from the University of Southern California in Los Angeles. He competed internal medicine residency at Rhode Island Hospital in Providence and a fellowship in infectious diseases at the University of North Carolina at Chapel Hill.

Dr. Britigan joined UNMC after seven years at the University of Cincinnati, where he was the Taylor Professor and chair of the department of internal medicine. Prior to that, he spent 17 years at the University of Iowa, where he was director of the division of infectious diseases, fellowship program director, and NIH T32 training grant PI for 11 years in the department of internal medicine. He also has had a greater than 30-year role as a staff physician and investigator in the United States Department of Veterans Affairs. He has been involved in medical student, graduate student, resident and postdoctoral fellow education throughout his career.

Research in Dr. Britigan's laboratory focuses on the biology of oxygen-centered free radicals and/or iron metabolism as they relate to host defense/inflammation. There is a particular emphasis on these events in phagocyte biology and the pathogenesis of infection with bacterial pathogens such as *Pseudomonas aeruginosa*, *Mycobacterium tuberculosis and Francisella tularensis*. His research has been funded over the years by NIH, the VA, and a variety of research foundations.

The author of more than 130 peer-reviewed publications, Dr. Britigan was elected to membership in the American Society for Clinical Investigation and the Association of American Physicians. He is a fellow of the Infectious Diseases Society of America and was the president of the American Federation for Medical Research from 1996-1997 and president of the Central Society for Clinical Research from 2010-2011. He continues to be clinically active in adult infectious diseases and medical education. He also has served for several years as a member of the review and selection committees for Executive Leadership in Academic Medicine Program that seeks to advance the careers of women in academic medicine. He has served as member of site visit teams for the Liaison Committee for Medical Education that is responsible for the accreditation of medical schools in the United States and Canada.



College of Medicine







The UNMC College of Medicine is the largest of UNMC's colleges, with approximately 1,100 full-time faculty and 22 departments. Tasked with expanding and transforming medical care throughout Nebraska and beyond, it also is the second least-expensive primary care medical school among the top schools ranked by U.S. News & World Report. As part of its effort to build the medical workforce in Nebraska, UNMC is opening a regional medical school campus at the University of Nebraska at Kearney in the fall of 2026, allowing 10 to 20 new students each year to begin their medical education in Central Nebraska. The Kearney initiative will build on the following accomplishments:



EDUCATION

- The UNMC College of Medicine has 527 medical students in 2023-34, a 1% increase from the previous year. This includes 35 students in the college's MD/PhD program.
- Last year, the college received more than 2,050
 applications and interviewed 378 candidates, all virtually
- Of the 134 students admitted, 77% are from Nebraska and 55% are women
- Student's average entering GPA is 3.87, and average MCAT is 512 (83rd percentile)

- **116 medical students** graduated in May of 2023
 - 50% are in residency training in a primary care discipline (family medicine, internal medicine, obstetrics and gynecology, and pediatrics).
 - 22% are in hospital-based specialties (anesthesiology, emergency medicine, radiology, pathology).
 - 18% are in surgical specialties (gen surgery, neurosurgery, ortho, urology, ophthalmology, otolaryngology).
 - 8% are in other specialties (neurology, psychiatry, dermatology, PM&R).
 - 38% stayed in Nebraska for residency.



- Average medical school debt at graduation of this year's class was approximately \$160,000. The national average is approximately \$200,000.
- 218 new UNMC residents and fellows started in July 2023:
 - 42% are women and 22% graduated from the UNMC College of Medicine.
- Currently, UNMC has 715 residents and fellows total in all years, with 233 positions in primary care.
 - 74 ACGME-accredited programs, an ADA accredited oral surgery program, and six non-ACGME accredited specialty training programs.
- The Association of American Medical Colleges ranks UNMC in the:
 - 99th percentile of schools whose graduates pursue careers in primary care.
 - 96th percentile of schools whose graduates who practice in rural areas.
 - 83rd percentile of schools whose graduates practice in the state in which they graduated from medical school.



The UNMC College of Medicine contains **80% of researchers at UNMC**, who receive 70% of research funding. The college's grant funding includes:

- \$121.8 million in research-specific awards for FY23.
- \$92.8 million from federal grants and contracts.
- \$20.3 million from industry grants and contracts.
- \$8.7 million from the state and other sources.

The college **ranked 58th of 144** medical schools in NIH funding in 2022.

In partnership with **Nebraska Medicine** and **Children's Hospital**, UNMC faculty provide:

A registered nurse since 1981, Dr. Sharp-McHenry previously served as dean of the College of Natural, Behavioral and Health Sciences at Simmons University in Boston, and as dean of the College of Nursing at Oklahoma Baptist University.

Dr. Sharp-McHenry received an associate's degree in nursing at Southern Arkansas University, bachelor's in nursing from the University of Arkansas, master's as a clinical nurse specialist in psychiatric mental health nursing from the University of Oklahoma, and a doctorate in nursing practice with a specialty

in executive leadership from Union University in Tennessee.

She has held leadership roles in national organizations such as the National Association of Directors of Nursing Administration in Long Term Care, National Council of State Boards of Nursing, American Association of Colleges of Nursing, Commission on Graduates of Foreign Nursing Schools, and Commission on Collegiate Nursing Education.

She published and co-authored articles and served as an expert panel member in the development of clinical practice guidelines in the long-term care field.

Keith Olsen, PharmD, FCCP, FCCM, serves as the Joseph D. Williams Endowed Dean of the UNMC College of Pharmacy, where he received his PharmD.

Dr. Olsen earned a Bachelor of Science in Chemistry at Wayne State College and completed a residency at Nebraska Medicine.

Dr. Olsen was on the UNMC faculty for two decades before serving as dean of the University of Arkansas Medical Sciences College of Pharmacy for three years.

Dr. Olsen is recognized as a Fellow of the American College of Clinical Pharmacy and the American College of Critical Care Medicine. He was elected to the Board of Regents of the American College of Critical Care Medicine in 2010 and 2013, serving as vice chancellor in 2017 and now current chancellor, the first pharmacist to do so. He was elected to the Board of Trustees Research Institute for the American College of Clinical Pharmacy in 2012.

He has published more than 350 peer-reviewed publications, abstracts and book chapters in the areas of critical care pharmacotherapy and infectious diseases.

Two graduating Doctor of Pharmacy classes have recognized him as the Distinguished Teacher of the Year. He is one of the co-developers of a Point-of-Care certification program for pharmacists.

The College of Pharmacy was started in 1910 on the University of Nebraska Lincoln, making a permanent move to UNMC in 1977. The College has long history of national and international leadership in education and research. The following is a short list of accomplishments by our faculty and students:

Ali Khan, MD, MPH, MBA, a former assistant surgeon general, is the third dean of the UNMC College of Public Health. Dr. Khan's vision is for the college to develop innovative strategies in helping to make Nebraska the healthiest state in the Union as a national global model.

He served at the Centers for Disease Control and Prevention for 23 years before retiring as the director of the Office of Public Health Preparedness and Response. In that role, he managed the \$1.5 billion public health security program and was responsible for CDC's public health preparedness and response activities. He provided strategic direction, support and coordination

for these activities across CDC, as well as with local, state, tribal, national, territorial and international public health partners.

Dr. Khan joined the CDC and U.S. Public Health Service Commissioned Corps in 1991 as an Epidemic Intelligence Service officer and over the past decades has led and responded to numerous high-profile domestic and international public health emergencies, including hantavirus pulmonary syndrome, Ebola hemorrhagic fever, monkeypox, avian influenza, Rift Valley fever, severe acute respiratory syndrome (SARS), the Asian Tsunami (2004), and the initial public health response to Hurricane Katrina in New Orleans.

In 1999, Dr. Khan served as one of the main architects of the CDC's public health bioterrorism preparedness program, which upgraded local, state and national public health systems to detect and rapidly respond to bioterrorism. As the deputy director of this novel program, he led the creation of the critical agent list that was the basis for all biological terrorism preparedness, published the first national public health preparedness plan with key focus areas to improve local and state capacities, and initiated pilots of syndrome-based surveillance and health data fusion.

These preparedness efforts were crucial in limiting the scope of the first anthrax attack, during which he directed the CDC operational response in Washington, D.C. More recently, he has focused on advancing our nation's health security by developing methods to improve public health knowledge exchange, integration and delivery; use of social media for crowd sourcing data, sharing information and soliciting volunteers; risk-based approaches to build robust public health systems and resilient communities; new metrics such as the national health security index – a composite measure of state preparedness; and emergency management programs globally.

Dr. Khan's professional career has focused on emerging infectious diseases, bioterrorism and global health security. He founded the Public Health Matters blog and has been personally engaged in guinea worm and polio eradication activities. While directing global infectious disease activities, he designed the laboratory component of the CDC's field epidemiology and training program. He also helped design and implement the CDC component of the \$1.2 billion, 5-year President's Malaria Initiative. He co-founded a novel center at the CDC to champion a One Health strategy to ensure health security from a myriad of zoonotic, vector-borne and food-borne infectious diseases. More recently he has focused on better integration of public health and healthcare for disease prevention, reducing health inequities, and the social determinants of health.

Dr. Khan received his medical degree from Downstate Medical Center in his hometown of Brooklyn, New York, and completed a joint residency in internal medicine and pediatrics at the University of Michigan at Ann Arbor before joining the CDC. He is a fellow of the American Academy of Pediatrics and the American College of Physicians. He has a master's of public health from Emory University's Rollins School of Public Health, where he was an adjunct professor and directed the emerging infections course, and a master's of business administration from the University of Nebraska Omaha.

He has more than 150 peer-reviewed publications, textbook chapters, editorials and brief communiqués. He has consulted extensively for multiple U.S. organizations, including the National Aeronautics and Space Administration, numerous ministries of health and the World Health Organization.





Emily J. Glenn, MSLS, serves as dean of the Leon S. McGoogan Health Sciences Library at UNMC. In this role, Glenn is responsible for the library's strategic direction, resources and services, plus a significant exhibit collection in the Wigton Heritage Center. She is a member of the University of Nebraska Consortium of Libraries Executive Committee. Prior to being named dean, she served as the library's associate dean, overseeing user services, collections, education and teaching, and technology. Munroe-Meyer Institute Director

Karoly Mirnics, MD, PhD, is director of the UNMC Munroe-Meyer Institute, which transforms the lives of individuals with intellectual and developmental disabilities. Dr. Mirnics obtained his MD from the University of Novi Sad School of Medicine in his hometown in 1986 and his PhD from Semmelweis University in Budapest, Hungary. He completed his postdoctoral fellowship at the University of Pittsburgh.

Dr. Mirnics established his own laboratory in 2000 at the Department of Psychiatry at the University of Pittsburgh, where he rose to the rank of

associate professor in 2006. That year, his laboratory moved to the Department of Psychiatry at Vanderbilt University in Nashville. In 2010, he was named James G. Blakemore Professor of Psychiatry, and he also served as the departmental vice chair for research and associate director of the Vanderbilt Kennedy Center.

Dr. Mirnics has a broad background in molecular neurobiology of brain diseases, with more than 20 years of experience in various molecular biology techniques. His research group is actively pursuing projects that include transcriptome changes across human brain diseases, animal models of neurodevelopmental and psychiatric disorders, effects of maternal immune activation and environment on gene expression, and neuroprotection by activity.

To illustrate his innovativeness and willingness to explore unconventional research: He was the first to perform a DNA microarray analysis of brain tissue, pioneered molecular pathway analyses, characterized immune system dysfunction in schizophrenia and autism, pioneered in situ proteomics in neuroscience, developed a new microarray platform, identified neuroprotection of enriched environment in Alzheimer's Disease models, holds a patent for RGS4 as a schizophrenia susceptibility gene, and developed a novel transgenic mouse technology, using BAC-driven, miRNA-mediated silencing in vivo. He has collaborated with more than 30 groups of investigators over the past 10 years.

EDUCATION:

The institute trains individuals in the medical and therapeutic management of individuals with disabilities and complex health care needs through interprofessional educational experiences, outreach training and onsite technical assistance. MMI has fellowships across several disciplines, an MMI-PhD program in applied behavioral analysis, and train graduate students in multiple disciplines through the Medical Sciences Interdepartmental Area program.



Interdisciplinary training in 2022 had **1907 students, interns, residents and post-doctoral fellows.** Of those 407 were long-term trainees participating in more than **300 hours of training**.



Annually, more than **130 courses** and seminars taught by our faculty and staff.

RESEARCH:

MMI conducts basic, translational and clinical research with the goal to transform the diagnosis, care and treatment of individuals with all types of disabilities and complex health care needs.



MMI has **56 active grants**, many of them collaborations with other universities, community organizations and the state and federal government. Federal grant funding totaled more than **\$5.9 million** in 2022.

COMMUNITY OUTREACH:

MMI provides statewide technical assistance and consultation to Nebraska public schools and other programs across the state that provide services to children, youth and adults with disabilities.



MMI had more than **8,800 participants** in workshops, conferences, teleconferences and other community education activities in domestic and international forums.



MMI also received more than **\$6.2 million** in philanthropoic contributions in the last calendar year.

Eppley Institute for Research in Cancer and Allied Diseases Director

Kenneth H. Cowan, MD, PhD, became the director of the Fred & Pamela Buffett Cancer Center (formerly the UNMC Eppley Cancer Center) and the Eppley Institute for Research in Cancer and Allied Diseases in August 1999. The Fred & Pamela Buffett Cancer Center, created in 1983, is an NCI-designated clinical cancer center, uniting cancer researchers throughout the UNMC campus into a larger single entity. The Eppley Institute was founded in 1961. Dr. Cowan is the sixth director in the institute's 40-year history. The Eppley Institute for Research in Cancer and Allied Diseases is a division of the University of Nebraska Medical Center with 27 basic science laboratories headed by principal investigators focused on cancer research.

Prior to this, since completing his residency training at Texas Southwestern Affiliated Hospitals in Dallas, Dr. Cowan spent 21 years in the Public Health Service at the National Cancer Institute. Since 1988, he served as chief of the medical breast cancer section, medicine branch. In his NCI position, he was responsible for overseeing laboratory researchers and clinical staff involved in basic and clinical research in breast cancer.

A New York City native, Dr. Cowan earned his undergraduate degree at the University of Rochester in Rochester, NY, and his medical and doctorate degrees from Case Western Reserve University in Cleveland. He has authored more than 240 papers for scientific journals and has been an invited guest lecturer at numerous scientific conferences.

Incoming Director



Joann B. Sweasy, PhD, an internationally recognized comprehensive cancer center director and an expert in the genetics, cell biology and biochemistry of DNA repair, will serve as the next director of the Fred & Pamela Buffett Cancer Center and the Eppley Institute for Research in Cancer and Allied Diseases.

A National Institutes of Health-funded researcher since 1994, Dr. Sweasy currently is director of the University of Arizona Cancer Center in Tucson. As UACC director, she led the center to renewal of its National Cancer Institute-Comprehensive designation in 2022.

Dr. Sweasy will begin her UNMC roles on Nov. 1 and succeed Ken Cowan, MD, PhD, who has led the cancer center since 1999.

Dr. Sweasy serves as a member of the NCI-subcommittee A, the panel that reviews all NCI cancer centers, and is vice president/president-elect of the American Association of Cancer Institutes.

Her research has been funded continuously by the National Institutes of Health since 1994 for her research on the genetics, cell biology and biochemistry of DNA repair and the roles of aberrant DNA repair in cancer and autoimmunity. For this work, she was awarded the 2016 Environmental Mutagenesis and Genomics Society Award, as well as many other national awards and recognitions.

Dr. Sweasy earned her bachelor's degree from Arcadia University and her doctoral degree from Rutgers, The State University of New Jersey. She was a postdoctoral fellow at the University of Washington. She then was appointed as an assistant professor in the department of therapeutic radiology at the Yale University School of Medicine, eventually earning tenure and serving as vice chair of the department and the Ensign Professor of Therapeutic Radiology. Dr. Sweasy joined the University of Arizona Cancer Center as director in 2019.

Eppley Institute for Research in Cancer & Allied Diseases

The Eppley Institute for Research in Cancer and Allied Diseases was founded in 1960 with funds from the Eugene C. Eppley Foundation, National Institutes of Health and the University of Nebraska. Dr. Henry M. Lemon was recruited as the first director. He reported to the Dean of the College of Medicine.

The purpose of the Eppley Institute, dedicated in 1963, was to provide a research center that could perform and encourage fundamental studies leading to a better understanding of the causes of cancer, the improvement of methods for diagnosis of cancer and improvement of methods for the treatment and prevention of cancer and similar disorders.

In 1972, by action of the Nebraska Legislature, the Eppley Institute became an independent research institute with the director reporting to the Chancellor of UNMC, rather than to the Dean of the College of Medicine.

In 1973, the Eppley Foundation, in collaboration with the National Cancer Institute (NCI) and UNMC, funded the construction of the Eppley Science Hall, which added 30,000 square feet of research space to the Institute.

In 1983 Dr. Edward Bresnick was appointed Director of the Institute. During his tenure, the Eppley Institute was awarded a Laboratory Cancer Center Support Grant from the NCI in 1983, which was renewed for five years in 1987. The award of this grant designated the Eppley Institute as a Laboratory Cancer Research Center. Under the leadership of Dr. Bresnick, the faculty was expanded to include cell and molecular biologists.

In August 1999, Dr. Kenneth H. Cowan became the director of the Eppley Institute for Research in Cancer and Allied Diseases and the Fred & Pamela Buffett Cancer Center (formerly the Eppley Cancer Center). Since completing his residency training at Texas Southwestern Affiliated Hospitals in Dallas, Dr. Cowan spent his entire career at the NCI before coming to UNMC. From 1988 to 1999, he was chief of the Medical Breast Cancer Section, Medicine Branch, and was a captain in the Public Health Service, which includes physicians in the National Institutes of Health.

The Eppley Institute currently has 31 faculty members who conduct basic science research. The Cancer Research Doctoral Program (CRDP), offered through the Eppley Institute, is the cornerstone of a National Cancer Institute-supported Cancer Biology Training Program at UNMC. The CRDP is one of the seven programs within the Interdisciplinary Graduate Program in Biomedical Sciences (IGPBS) and includes over 100 faculty from the Eppley Institute and other basic and clinical departments within UNMC. There are currently 52 students in the CRDP Program.

Fred & Pamela Buffett Cancer Center

Fred & Pamela Buffett Cancer Center

The Fred & Pamela Buffett Cancer Center (formerly the Eppley Cancer Center) is the only National Cancer Institute (NCI)-designated cancer center in Nebraska, a distinction held by only 72 cancer centers in the country. This recognition means the most current and innovative treatment options are available to all patients through the integration of cutting-edge cancer research into state-of-the-art care. The Fred & Pamela Buffett Cancer Center has held its NCI designation since 1984.

Well-established multidisciplinary research programs in the Cancer Center include the Targets, Modulators and Delivery Program (TMDP), the Cancer Biology Program (CBP), the Gastrointestinal Cancer Program (GICP) and the Cancer Prevention and Control Program (CPCP). These programs focus on discovering the mechanisms which cause cancer to develop and translating these discoveries into new approaches for early detection of cancer and new therapies for cancer treatment and cancer prevention as soon as possible.

The Fred & Pamela Buffett Cancer Center has over 200 members who conduct basic and clinical research and provide patient care throughout the University of Nebraska system. Over 140 new faculty have been recruited to the Fred & Pamela Buffett Cancer Center since 1999, when the current director, Kenneth Cowan, MD, PhD joined the organization. Extramural funding for Cancer Center members has increased from \$19 million in 1999 to over \$60 million today.

The \$323 million Fred & Pamela Buffett Cancer Center opened in June 2017. The facility was named in recognition of a gift from Pamela Buffett, through her foundation, the Rebecca Susan Buffett Foundation. Pamela's husband, Fred "Fritz" Buffett, died in 1997 after fighting kidney cancer. This state-of-the-art facility consists of the Suzanne and Walter Scott Research Tower, a 10-story, 98 laboratory research tower; the C.L. Werner Cancer Hospital, an eight-story, 108 bed inpatient treatment center and a multidisciplinary outpatient center which includes clinics, radiation oncology, surgery, radiology, a 24/7 treatment center and lab. Unique in its design, the Buffett Cancer center puts clinical providers in close proximity with research colleagues with the goal of more efficiently translating research in the laboratory to novel therapies for patients in the clinic.

The Fred & Pamela Buffett Cancer Center facilitates collaboration between researchers and clinicians, with the building being specifically designed to house everything associated with cancer in one area on campus, making it convenient for patients.

Joann B. Dr. Anderson Berry received her

John-Martin Lowe, PhD, is the director of the Global Center for Health Security, assistant vice chancellor for health security training and education, and professor of Environmental, Agricultural and Occupational Health at the University of Nebraska Medical Center. At the University of Nebraska Medical Center, he leads research and training initiatives to advance environmental risk assessment and infection control for high consequence pathogens.

As a virologist and environmental exposure scientist, John Lowe, PhD, has worked extensively throughout the U.S., Africa, Asia and Europe as an

educator, researcher and in health emergency risk management related to infectious disease, infection control and emergency response. His expertise focuses on infectious disease risk assessment and management of risk for clinical, community and industrial environments. Dr. Lowe also has extensive experience in emerging pathogens and health security. He is co-PI for the U.S. National Emerging Special Pathogens Training and Education Center, established an international network for emerging infectious diseases, and served lead investigator for a multi-country bio-surveillance network in Africa. He has experience in a broad range of health security topics from surveillance, public health response and clinical response to health emergencies. Dr. Lowe led successful COVID-19 efforts in 2020 at the National Quarantine Unit and Nebraska Biocontainment Unit to provide monitoring and care for repatriated U.S. citizens exposed to and infected with SARS Coronavirus 2. He also led early and continued efforts to characterize the transmission dynamics of SARS Coronavirus 2 which were presented to in a joint meeting hosted by the Academy of Medicine and American Public Health Association on April 15, 2020.

Dr. Lowe has co-authored numerous book chapters and scientific papers on control and response to emerging pathogens. He also provided technical consultation and participated in infection prevention and control as well as industrial hygiene in over 23 countries to a variety of industry sectors including healthcare, food production, hospitality, finance, and insurance for issues related to emerging pathogens including Ebola virus disease and COVID-19.




The Global Center for Health Security

Proactive Research | Active Response

The University of Nebraska's Global Center for Health Security (GCHS) was established in 2017 to provide a platform for health system preparedness, recognition, and response to catastrophic public health emergencies while also providing comprehensive capabilities in research, education and training, and health system operations.

The GCHS has become an invaluable national and international resource for the management of high consequence infections. In February of 2020, 57 repatriated Americans from Wuhan, China, and 13 Diamond Princess cruise ship passengers were evacuated and brought to Nebraska, where they were housed in the nation's only federally-funded quarantine unit (The National Quarantine Unit) and the Nebraska Biocontainment Unit.





CLINICAL The Global Center for Health Security is the premier U.S. institution for management of high-consequence infections. Further, clinical capabilities exist in all hazards and all domains of CBRNE (Chemical, Biological, Radiological, Nuclear, and high yield Explosives).

RESEARCH The GCHS has laser-focused existing work by our leading scientists in fields like chemical weapons, drug discovery and public health. Through our partnerships and preparation, the Global Center for Health Security is forging advances in biopreparedness and in moving critical, life-saving discoveries out of the lab and into clinical trials.

EDUCATION & TRAINING Our expertise is now sought worldwide and officially sanctioned by the U.S. government. The GCHS is the home base to the national Training, Simulation, and Quarantine Center and the Nebraska Biocontainment Unit.

INNOVATION & EXTERNAL PARTNERSHIPS

The GCHS has partnered with many academic groups at UNMC and external partners to tackle the most pressing problems in emerging infectious diseases. Core Programs

National Emerging Special Pathogens Training and Education Center (NETEC)

- Sets the gold standard for special pathogen preparedness and response across U.S. health systems; drives best practices, closes knowledge gaps, develops resources.
- Defining core capabilities for the tiered system and creating a robust regional hub and spoke model through the National Special Pathogen System (NSPS).

Region VII Disaster Health Response Ecosystem (R7DHRE)

- Create a flexible, self organized, grassroots disaster readiness network across Region VII.
- Specialty teams include behavioral health, biological, chemical, pediatric, radiological and trauma.



Region VII Special Pathogen Treatment Center (RESPTC)

- Since 2005, the Nebraska Biocontainment Unit (NBU) has led the nation in special pathogen preparedness and response by continuously delivering high quality care for patients with highly hazardous communicable diseases.
- Assists facilities for preparedness via educational videos, webinars, workshops, targeted technical assistance, and exercises.

Public Health Training Service (D-SAFE)

- United States Public Health Service partnership with UNMC GCHS/University of Texas Health Science Center at Houston, and Texas A&M University to create and implement Public Health Service Deployment Safety Academy for Field Services (PHS D-SAFE).
- Provides personal safety and security training to USPHS officers that may be deployed to environments with potential for exposure to high consequence infectious diseases.

National Disaster Medical System Pilot Program (NDMS)

- Strengthens interoperable partnerships across the NDMS to care for the U.S. combat casualties by increasing medical surge capabilities and capacity.
- Strives to establish a collaborative network of federal and civilian partners to inform and enhance system-wide medical surge capacity, capability, and interoperability.

National Infection Control Strengthening (NICS)

 Focuses on strengthening infection prevention and control programs in healthcare facilities in underserved areas to develop innovative programs, services, and product development strategies to strengthen IPC nationally and globally.

Emerging Pathogens Lab

- A CLIA-certified, high-complexity clinical laboratory
- Bridges infectious diseases diagnostic development with patient-and community-centered implementation strategies.

Training, Simulation, and Quarantine Center (TSQC)

Nebraska Quarantine Unit

- Designed to provide quarantine to individuals exposed to highly hazardous communicable diseases.

Nebraska Biocontainment Unit

- Provides care for patients with highly hazardous infectious diseases
- Offers education via courses, webinars, video, and zoom conversations on relevant topics to share knowledge and expertise.

Deployable Teams

- Ability to rapidly staff and deploy teams of technical experts responsive to the needs of response organizations, federal partners, and international non-governmental organizations.
- Focus on agile, forward-leaning, advanced teams that can meet the subject matter or operational need of hazards.
- Teams have been deployed to a myriad of technical areas including decontamination, PEE, research, emergency management, and special pathogens response.

GCHS Ethics Advisory Committee

- Provides analysis and resolution of ethical issues extending to bioethics issues within research, clinical, and public health ethics.
- Resolved multiple issues involving crisis standards of care during the COVID-19 pandemic

Special Pathogens Research Network (SPRN)

- Network of U.S. institutions with high-level clinical isolation units committed to development and maintenance of rapid response clinical research infrastructure.
- Rapidly implements special pathogens clinical trials and expands access to investigational new drug protocols.

Dr. Pamela Boyers' professional interest is to ensure that health care professionals (at all levels of training) are highly prepared to provide the safest possible patient care. This interest includes paying close attention to the well-being of health care professionals – and how they learn to work efficiently and effectively in health care teams.

Concerned with the escalating number of avoidable deaths due to medical error, Dr. Boyers focus is upon transforming the education of health care

professionals through the adoption of modeling and simulation. She has provided national and global leadership in the concept of creating interprofessional simulation centers. This includes the design, staffing and operations of these centers as well as studying the return on investment. Her professional goals are to advance interprofessional collaboration and see health care move toward a competency-based model of training.

Having served in medical education leadership positions at the University of North Carolina, The Ohio State University, OhioHealth and the University of Toledo, Dr. Boyers is currently leading efforts at UNMC to "improve human performance and effectiveness in health care." This involves creating the Davis Global Center in Omaha – this five-level facility houses an interprofessional simulation center that incorporates a replicated health care system – from home to hospital and back - where the transfer of patients and "hand-offs" can be practiced. The Davis Global Center also houses multiple modeling and simulation modalities including XReality (including holographic) technologies, thereby embracing modeling, simulation and visualization to stimulate new methods of teaching, learning and conducting research and development.

A lifelong medical educator with significant experience in designing and operating medical simulation centers, Dr. Boyers is well-published and speaks nationally and internationally about transforming the education of healthcare professionals. She enjoys collaborating with other high reliability organizations, including the military, to help identify best training practices related to improving quality, safety and lowering costs.

Dr. Boyers previously served for many years as one of the public members for the American Board of Medical Specialties (ABMS) and is an active member of the National Training Simulation Association (NTSA): Patient Safety Workgroup.

Davis Global Center

Global leadership in improving human performance and effectiveness

The **Dr. Edwin G. & Dorothy Balbach Davis Global Center (Davis Global Center)** serves as headquarters for iEXCEL. This multi-level, 192,000 gsf clinical simulation facility became fully operational in 2020 on the University of Nebraska Medical Center campus in Omaha, Nebraska. The Global Center for Health Security is located within the Davis Global Center, sharing simulation and visualization assets and staff expertise.

Proximal to the UNMC colleges and Nebraska Medicine, the Davis Global Center serves as the catalyst for an integrated statewide, national and global simulation initiative. All five levels of the facility work together as one collaborative unit to create safe, innovative and experiential training environments as well as a venue for research and business development.

Davis Global Center Capabilities: A Replicated Total Healthcare System

- 3D, augmented/virtual reality (AR/VR) technologies, including a holographic theater
- Dedicated spaces for the creation of innovative teaching modules and videos
- Designed to practice the transfer of patients between levels of care ("hand-offs")
- Replicated clinics, hospitals, ambulatory and home care units for simulating incidents, events and patient care scenarios
- Opportunities for training to competency before encountering real-life patient care and emergency response situations
- Surgical skills procedure rooms/operating bays with fresh tissue simulation for practicing high-level, complex patient care procedures
- Collaboration with other disciplines, especially STEAM (science, technology, engineering, arts and mathematics) initiatives
- Tele-education, tele-presence and tele-mentoring capabilities
- Hosting and educating teams of interdisciplinary practitioners and learners of all disciplines and at all levels of training
- Highly-specialized training in health security and biopreparedness in the Global Center for Health Security

Lower Level: iEXCEL Simulated Community Care

- Home care unit for training in emergency response, home safety evaluations and transfer from home to hospital
- Ambulance bay to practice transportation of patients and transfer of care from emergency medical services (EMS) to the hospital

Ground Level: Global Center for Health Security

- 6-bed biocontainment clinical training and simulation unit for professionals to learn to care for and conduct procedures for patients with highly infectious diseases
- 20-bed National Quarantine Unit
- Multi-purpose room with emergency operations center (EOC) capabilities and training facility

Level 1: iEXCEL Visualization and Virtual Reality

- 3D, AR/VR technologies to inspire and foster curriculum innovation and collaborations with industry and military
- Holographic Theater (70 seats): holographic stage produces extraordinary virtual images
- iEXCEL Helix: 200-degree 2D curved screen is an interactive, digital iWall displaying images individually or collaboratively with other sites
- iEXCEL Laser CAVE 5: Fully immersive, five-sided 3D laser cave expands learning and research and development opportunities

Level 2: iEXCEL Interprofessional Simulation

Realistic simulated hospital units where clinical competencies and team communication are learned, practiced and tested with lifelike simulators and real-world clinical equipment.

- The Acute Care Unit has a realistic, simulated operating room (OR), a labor and delivery room, patient rooms and a pediatric unit
- The Critical Care Unit has a realistic, simulated emergency department, trauma unit, intensive care unit and imaging room
- Procedural Skills Labs
- Pre-briefing and debriefing rooms for session preparation and review of recorded sessions

Level 3: iEXCEL Surgical and Interventional Skills

Advanced surgical skills training in replicated ORs using fresh tissue and surgical simulators. The facility provides a venue for collaboration with industry for training workshops and research and development.

- Surgical Skills Suite with 20 OR bays and a command center for recording and broadcasting locally, nationally and globally
- Hybrid OR/Interventional Suite for surgical training sessions
- Surgical Skills Labs with surgical simulators to practice and improve essential skills including handeye coordination, depth perception and suturing

The Davis Global Center is home to the EON/iEXCEL Virtual Reality Innovation Academy (VRIA) and Simulation in Motion-Nebraska (SIM-NE).



Virtual Reality Innovation Academy (VRIA) provides AR/VR skills training to students looking to enhance their careers. The course includes an intensive study in the underpinnings of various focus areas such as AR/VR, 3D content creation, coding and project management. Students also experience a project-based learning period, providing the opportunity to be part of a team pro ect and build confidence in their skills. Upon completion, students will receive an AR/VR Developer Certification. This program is a collaboration between iEXCEL and EON Reality.



Simulation in Motion-Nebraska (SIM-NE) is a statewide, mobile education system bringing state-of-the-art hands-on training, using high-fidelity human patient simulators, to pre-hospital and hospital professionals throughout Nebraska. SIM-NE provides standardized high-quality training to ensure consistent outcomes to rural EMS agencies and critical access hospital emergency rooms across the state. The program caters offerings to different communities with a variety of courses that can be customized to meet local needs.





The Davis Global Center serves as the hub for a statewide network of interconnected simulation centers. These conjoined centers (Scottsbluff, Norfolk, Kearney, Lincoln and Omaha) promote experiential training opportunities and stimulate new and unique research endeavors made possible by the availability of advanced modeling, simulation and visualization technologies. Collectively, these technologies will accelerate the development of a transformational model for individuals and interdisciplinary teams, at all levels of training and skills refreshment.

An Infinity Wall

The atrium features a 23-foot-tall Infinity Wall, the largest Crystal LED wall in the western hemisphere. This wall stimulates innovation in teaching, learning and research as a versatile tool for video, digital assets, cutting-edge presentations and more.



Clarkson Regional Health Services Holographic Theatre

In bringing learning to life, iEXCEL utilizes the first holographic theatre in any academic institution in the world. Using the latest in Direct View LED displays, theatre productions transform learning via lectures and presentations as immersive holographic 3D content.



Home Instead Helix

Connected to UNMC campuses throughout Nebraska, large interactive touchwalls facilitate group collaboration and experiential learning. The largest installation is the Home Instead Helix, a 20-foot wide, 280-degree curved environment comprised of 30 interactive panels.



Laser CAVE - 5

The Laser CAVE is a first-of-its-kind laser-illuminated, five-sided fully immersive space. The visual fidelity and high pixel density creates a "full-body" experience for users involving sight, sound, physical movement and interaction. Over 70 million pixels surround the user within this 10 feet by 10 feet by 10 feet space.

3D Workbenches

3D Workbenches are self-contained units that combine augmented and virtual reality (AR/VR) for individuals or small groups. Experiential learning with 3D visuals, infrared eye tracking and haptic feedback facilitate kinesthetic immersion. The compact size and ease of use promotes self- directed learning for students to practice at their own pace.

3D CADWalls

The 3D CADWalls are active three-dimensional displays coupled with motion capture technology to allow for a variety of experiences for learners. The large screen size and 3D effect allows groups of students to simultaneously experience content together, while infrared tracking facilitates precise interactions for single users.





Advanced Clinical & Surgical Simulation

The design of the Davis Global Center replicates the entire healthcare system. Human patient simulators, task trainers, virtual reality simulators and standardized patients are all utilized to create experiential hands-on training sessions. The facility is a certified Society of American Gastrointestinal and Endoscopic Surgeons (SAGES) testing center complete with FLS, FES and FUSE testing capabilities.

Augmented Reality (AR) & Virtual Reality (VR)

Learners are able to visualize complex concepts and simulate healthcare scenarios using a variety of head mounted displays (HMD) with augmented reality (AR), virtual reality (VR) and mixed reality. The iEXCEL visualization team collaborates with faculty, students and clinicians to create realistic, high-fidelity content for these emerging platforms.

Karoly Mirnics, MD, PhD, is director of the UNMC Munroe-Meyer Institute, which transforms the lives of individuals with intellectual and developmental disabilities. Dr. Mirnics obtained his MD from the University of Novi Sad School of Medicine in his hometown in 1986 and his PhD from Semmelweis University in Budapest, Hungary. He completed his postdoctoral fellowship at the University of Pittsburgh.

Dr. Mirnics established his own laboratory in 2000 at the Department of Psychiatry at the University of Pittsburgh, where he rose to the rank of

associate professor in 2006. That year, his laboratory moved to the Department of Psychiatry at Vanderbilt University in Nashville. In 2010, he was named James G. Blakemore Professor of Psychiatry, and he also served as the departmental vice chair for research and associate director of the Vanderbilt Kennedy Center.

Dr. Mirnics has a broad background in molecular neurobiology of brain diseases, with more than 20 years of experience in various molecular biology techniques. His research group is actively pursuing projects that include transcriptome changes across human brain diseases, animal models of neurodevelopmental and psychiatric disorders, effects of maternal immune activation and environment on gene expression, and neuroprotection by activity.

To illustrate his innovativeness and willingness to explore unconventional research: He was the first to perform a DNA microarray analysis of brain tissue, pioneered molecular pathway analyses, characterized immune system dysfunction in schizophrenia and autism, pioneered in situ proteomics in neuroscience, developed a new microarray platform, identified neuroprotection of enriched environment in Alzheimer's Disease models, holds a patent for RGS4 as a schizophrenia susceptibility gene, and developed a novel transgenic mouse technology, using BAC-driven, miRNA-mediated silencing in vivo. He has collaborated with more than 30 groups of investigators over the past 10 years.

Jeffrey P. Gold, MD, is a nationally recognized leader and tireless advocate for transforming higher education, academic medicine and health care delivery across the public and private higher education spectrum.

He became the eighth chancellor of the University of Nebraska Medical Center, vice president of the University of Nebraska System and chair of the board of UNMC's principal clinical care academic health system partner, Nebraska Medicine, in early 2014.

In July 2021, Dr. Gold also was named provost and executive vice president of the University of Nebraska System, in addition to his ongoing UNMC/Nebraska Medicine responsibilities. In this role, Dr. Gold is the chief academic officer of the University of Nebraska System of approximately 50,000 learners, over \$750 million of research and liaison to the Board of Regents for all aspects of academic affairs.

As UNMC's chief executive officer, Dr. Gold is responsible for all aspects of campus leadership, program quality and operations, including seven colleges, two degree-granting institutes, the entire professional staff and faculty of more than 6,000 and 4,700 health professions students. Additionally, Nebraska Medicine has more than 8,500 employees and an operating budget of more than \$2.3 billion.

The combined annual economic impact of the "500-mile campus" academic health center with 37 Centers of Excellence exceeds \$6.4 billion and employs more than 52,000. During this time, the UNMC enrollment has grown by just more than 43%, the sponsored research programs by more than 300% and the clinical programs by more than 150%.

In his systemwide roles as provost and executive vice president, Dr. Gold oversees all undergraduate, graduate and professional academic education, research and experiential programs as well as the student support areas for the University of Nebraska system campuses, approximately 50,000 students, more than \$750 million in research and a combined economic impact of over \$10 billion.

From May 2017 to June 2021, Dr. Gold also served as chancellor of the University of Nebraska Omaha, the state's only public metropolitan university and its most diverse campus. The UNO complex has seven thriving colleges, an enrollment of more than 13,000 undergraduate students, 3,000 graduate students, a broad public service mission and two NCAA Division I-A athletic programs. Following more than four highly successful years of growth and prominence at UNO, in 2021, he stepped down to assume the University of Nebraska System provost and executive vice president responsibilities across all undergraduate, graduate and professional programs.

Dr. Gold holds a tenured faculty appointment at the rank of professor in the UNMC College of Medicine, as well as in the UNMC College of Public Health, where his active research interests in health care policy, population health and epidemiology are concentrated. He also leads several key economic development boards for the state and the university system, including the Greater Omaha Chamber, University Technology Development Corp, the University Technology Transfer Corp, Nebraska Enterprises Corp, UNeTecH Corp, and several others.

Prior to joining UNMC, Dr. Gold served as chancellor of the University of Toledo's academic and clinical health sciences, which includes the colleges of Medicine, Nursing, Pharmacy, Health Science and Human Service, and Graduate Studies. In that role, Dr. Gold had full leadership responsibility of the clinical, education and research programs, the faculty practice plan and the integrated hospital and ambulatory health care delivery system.













The number and distribution of Nebraska healthcare workforce does not support the current and future health of our communities





IV. Summary and Recommendations

Since the 2020 report "The Status of the Healthcare Workforce in the State of Nebraska," the distribution of the healthcare workforce has shown modest improvements but only for a few professions. Overall, the healthcare workforce trends point to continuing challenges to delivering health care in rural regions." For example, although the relative distribution of OB/GYN physicians has improved since 2019, there are still 44 counties that lack obstetrical and gynecologic coverage. Moreover, the number of OB/GYN physicians continues to decline. Similar declining trends can be observed for all the physician types since 2019; the number decreased from 4,971 in 2019 to 4,906 in 2021. As concerning, most of the specialties examined in the report are increasing in average age. Among physicians, 19.4% are now aged 61 years and older, compared to 18.6% in 2019.

Each clinic:



Dr. Pamela Boyers' professional interest is to ensure that health care professionals (at all levels of training) are highly prepared to provide the safest possible patient care. This interest includes paying close attention to the well-being of health care professionals – and how they learn to work efficiently and effectively in health care teams.

Concerned with the escalating number of avoidable deaths due to medical error, Dr. Boyers focus is upon transforming the education of health care

professionals through the adoption of modeling and simulation. She has provided national and global leadership in the concept of creating interprofessional simulation centers. This includes the design, staffing and operations of these centers as well as studying the return on investment. Her professional goals are to advance interprofessional collaboration and see health care move toward a competency-based model of training.

Having served in medical education leadership positions at the University of North Carolina, The Ohio State University, OhioHealth and the University of Toledo, Dr. Boyers is currently leading efforts at UNMC to "improve human performance and effectiveness in health care." This involves creating the Davis Global Center in Omaha – this five-level facility houses an interprofessional simulation center that incorporates a replicated health care system – from home to hospital and back - where the transfer of patients and "hand-offs" can be practiced. The Davis Global Center also houses multiple modeling and simulation modalities including XReality (including holographic) technologies, thereby embracing modeling, simulation and visualization to stimulate new methods of teaching, learning and conducting research and development.

A lifelong medical educator with significant experience in designing and operating medical simulation centers, Dr. Boyers is well-published and speaks nationally and internationally about transforming the education of healthcare professionals. She enjoys collaborating with other high reliability organizations, including the military, to help identify best training practices related to improving quality, safety and lowering costs.

Dr. Boyers previously served for many years as one of the public members for the American Board of Medical Specialties (ABMS) and is an active member of the National Training Simulation Association (NTSA): Patient Safety Workgroup.

Sunil Hingorani, MD, PhD, a highly accomplished and internationally recognized pancreas cancer researcher and clinician. He is the inaugural recipient of the Nancy Armitage Pancreas Cancer Clinical Research Presidential Chair and the first director of the Pancreatic Cancer Center of Excellence at UNMC and Nebraska Medicine.

At UNMC, Dr. Hingorani conducts and oversees a comprehensive translational research program, while also leading development of a real-time, multi-

disciplinary clinic for pancreas cancer patients at Nebraska Medicine.

Dr. Hingorani's research success is well-documented. He helped develop the first mouse models to accurately mimic human pancreas cancer from its precancerous inception to its advanced stages. Dr. Hingorani has used these models to identify genetic events, signaling pathways and collaborating cell types that contribute to the aggressiveness of ductal adenocarcinoma, the most common and deadly form of pancreas cancer. Dr. Hingorani has made multiple breakthroughs in his lab that have informed the course of his latest phase of research, as well as that of others, and his lab is testing these ideas in a novel Murine Clinical Trials Program to identify those strategies most likely to succeed in patients.



- 7. Transferred and reconstructing the Murine Clinical Trials Program (MCTP) which serves as the preclinical engine for Precision Promise

Establish UNMC and its educational programs as the most learner-centered university in health professions, biomedical and interprofessional education.

Strategy 1.1

Globally lead health care education by providing an innovative, competency-based, and individualized curriculum. Globally lead health care education by providing an innovative, competency-based, and individualized curriculum that meets the life-long learning needs of each UNMC learner.

Strategy 1.2

Strengthen programs with K-12 schools, community, and state colleges. Work with K-12 schools, community, state and other Nebraska colleges, and University of Nebraska campuses to engage students in Nebraska and beyond in health care careers and establish strong career pathway programs to build a highly motivated and inclusive health professions workforce.

Strategy 1.3

Provide professional development for a faculty that expands UNMC current & future programs. Actively recruit, educate, and employ those faculty needed to advance UNMC professional education, biomedical and health care research and public health. Provide continuing education programs that meet current and future workforce needs.

Strategy 1.4

Continuously evolve resources for the Interprofessional Experiential Center for Enduring Learning (iEXCEL). Work with college curriculum committees to expand undergraduate and graduate academic program integration with iEXCEL. Continually assess educational and outcomes for iEXCEL in experiential learning to meet the educational goals and learning styles of each UNMC learner. Accelerate commercialization opportunities that protect iEXCEL intellectual property and enhance iEXCEL business development with the public and private sectors.

Strategy 1.5

Prepare UNMC health profession learners to be lifelong learners and leaders. Prepare all UNMC health profession learners to assume leadership roles in patient safety, prevention of medical errors, health care redesign, and the use of advanced technology including artificial intelligence and advanced simulation that improve health outcomes locally and globally.

Strategy 1.6

Assure UNMC Digital Campus technology and support is continually advanced for all academic units at UNMC. Provide active and adaptive learning of trainees, increase educational outreach to community and statewide Nebraska colleges to reduce technology related barriers, and evaluate the impact of emerging technologies (such as AI & ChatGPT) on the learning environment.

Strategy 1.7

Establish additional training pathways for all UNMC colleges and institutes. Develop and implement new degrees, stackable certificates and non-credit programs offering a solid foundation of experiential learning. Pathways include clinical and research aspects of global health security, advanced cancer screening, novel drug discovery, and improved outcomes of health care.

Strategy 1.8

Accelerate strategic & sustainable growth of graduate medical education programs. Work with all clinical partners to develop strategic and sustainable growth of graduate medical education (GME) programs to assure the quality of future clinical programs, as well as faculty to meet regional health care needs. Effectively utilize the supplemental Federal CMS resources to expand and strengthen rural and urban GME programs.

Strategy 1.9

Mature the Center for Community-based Education and Preceptor Excellence. Mature the administrative and technology structures to ensure excellence in preceptor and community-based learning experiences to ensure access to the current and future needs for high quality clinical learning experiences for students and community/clinical partners throughout the State of Nebraska and beyond.

Goal 2.0

Research Scope & Prominence

Increase the research scope, prominence, and impact of UNMC as a top tier academic health sciences center.

Strategy 2.1

Assure high impact research collaboration for UNMC with our academic and clinical partners. Strengthen research collaboration between UNMC and with our academic and clinical partners in clinical trials, industry collaboration, population health, outcomes research and formation of clinical/translational science partnerships locally and globally.

Strategy 2.2

Grow UNMC university-wide biomedical informatics research. Enhance UNMC university-wide biomedical informatics infrastructure to further develop biomedical, public health, clinical and translational research, to leverage deep-learning, machine-learning and augmented intelligence.

Strategy 2.3

Increase extramurally funded, sustainable, high impact research programs in current and emerging areas of research excellence. Build upon existing strengths and enhance existing collaboration through new partnerships both internal and external to UNMC.

Strategy 2.4

Expand educational research in the science of teaching and learning. Expand research in the science of teaching and learning, including educational pedagogy, curricular design, and delivery, as well as interprofessional experiential learning to determine those factors that improve individual educational, intercultural, and well-being outcomes.

Strategy 2.5

Strengthen and implement initiatives in cancer prevention and population health. Define and implement the community specific statewide research, educational and outreach initiatives in cancer prevention and population health that will result in increased community prevention, early diagnosis, consistent with NCI Comprehensive Center designation requirements for the Fred and Pamela Buffett Cancer Center.

Strategy 2.6

Globally lead the in human performance research in advanced simulation environments.

Globally lead the in human performance research in Al as well as in AR/VR and advanced simulation environments, including innovative basic, clinical, and transformational research strategies to assess human-factors performance to assure high-quality, high reliability health care.

Strategy 2.7

Utilize the UNMC Rural Health Center to assess and enhance rural Nebraska health care.

Assess and enhance health care delivery in rural Nebraska. Utilize the UNMC Rural Health Center to assess rural Nebraska health care outcomes and workforce needs, coordinate pathway programs for new students, and promote and enhance the quality and stability of rural health workforce.

Strategy 2.8

Extend access to clinical trials including in rural and urban underserved communities. Engage in partnerships that can conduct clinical trials across the state with local and regional health facilities to provide clinical trials of importance to Nebraskans.

Strategy 2.9

Grow our relationship with the University Institutes to provide more opportunities for research. Expand research collaboration and infrastructure support for our University Institutes (Buffett Early Childhood Institute, Daugherty Water for Food Institute, National Strategic Research Institute) partners leveraging the relationships and contracting capabilities of UNMC philanthropic and Federal entities.

Goal 3.0

Clinical Excellence

Establish UNMC and our clinical partners as an academic health system that provides the highest-quality care, recognized for outstanding patient outcomes, and compassionate, patient-centered care.

Strategy 3.1

Build relationships with our clinical partners to improve patient health outcomes by implementing new care models. Strengthen existing relationships with clinical partners to reduce health care disparities, improve patient health, and health care access and delivery to all Nebraskans.

Strategy 3.2

Utilize interprofessional practice to provide optimal patient care environments. Collaborate across the disciplines to ensure an interprofessional practice model across all UNMC Colleges, Institutes and programs in conjunction with our clinical partners to provide optimal learning and patient care in all clinical care settings.

Strategy 3.3

Achieve top decile performance in all quality clinical outcomes and patient experience.

Achieve top decile or higher performance in high reliability benchmarked outcomes for clinical quality, patient safety and patient experience across the clinical enterprises of our clinical partners. Use high fidelity simulation, virtual reality and artificial intelligence learning to sustain the top decile performance.

Strategy 3.4

Assure timely access to UNMC clinical care services. Assure patient-centered and timely access to inpatient and outpatient clinical care services while simultaneously assuring proficiency with enhancing the experiential factors of advanced technologies for patients, families, and health care professionals.

Strategy 3.5

Improve virtual telehealth patient outreach through use of Al, wearable & mobile devices.

Expand UNMC virtual telehealth and telemonitoring medical and behavioral programs including use of augmented intelligence systems and mobile/wearable devices to assist UNMC providers and other clinical partners improve patient outreach and clinical care.

Strategy 3.6

Mature planning and implementation of the Phase I of Nebraska Medicine Project NExT.

Enhance the key program and facility planning of the Nebraska Medicine first phase of Project NExT assuring clinical partnerships related to the clinical, research and educational programs that are mission critical for UNMC. Mature the fiscal planning and partnership support structures for Project NExT Phase I.

Strategy 3.7

Utilize the Rural Health Center to align UNMC with state-wide partners. Utilize the Rural Health Center to align the clinical strategies and planning for UNMC and its colleges with state-wide educational and clinical partners to identify new models of health care delivery through assessment of population health, health access disparities, social determinants of health and health literacy. To include necessary changes to state-wide health policy that improve the health of all Nebraskans and reduce health care costs.

Strategy 3.8

Utilize evidence-based, personalized precision medicine to enhance clinical outcomes.

Develop and utilize evidence-based, personalized precision medical protocols and practices that assure the UNMC patients and clinical partners have direct and quality contact time with health care providers. Monitor the outcomes and continually improve the evidence-based standards of practice.

Goal 4.0

Community Engagement

Provide a healthier future for all Nebraska communities through increased community engagement.

Strategy 4.1

Develop & expand public-private partnerships with state departments and agencies. Work closely with the Office of the President and sister campuses to create and expand public-private partnerships with state departments and agencies to promote statewide population health assessments and increase Nebraskans engagement in healthy activities with the goal of improving health equity, reducing disparities related to access to care to and make Nebraska the healthiest state in the Union.

Strategy 4.2

Work with public & private partners to diversify & strengthen the Nebraska economy.

Continually work with the Office of the President and our sister campuses as well as other public and private organizations to diversify and strengthen the Nebraska economy. Partner with a wide

spectrum of health care organizations to provide incentives, including tuition debt reimbursement of health care professionals who seek employment in underserved urban and rural Nebraska communities and serve as preceptors of health profession students and residents.

Strategy 4.3

Strengthen UNMCs federal and state and local involvement in support of academic health care. Strengthen UNMCs federal and state legislative involvement and advocacy in supporting health care, health professions education, biomedical research, and population-based care delivery, facilities, policy, and planning in partnership with the Office of the President.

Strategy 4.4

Strengthen the Global Center for Health Security impact in research, practice, and education. Strengthen UNMCs national and global leadership in High Reliability Health Security and Biocontainment research and education/training programs of the Global Center for Health Security. Continue to build and strengthen federal, state, and local collaborations.

Strategy 4.5

Promote UNMC as the multimedia information resource for rural, national, and global health. Promote UNMC as the data rich digital health multimedia resource for rural, national, and global health issues. Strengthen UNMCs communication and engagement with urban and rural Nebraskans to make them aware of health and wellness resources and educational opportunities.

Strategy 4.6

Strengthen state-wide programs to reduce rural and urban health care disparities. Strengthen state-wide planning and ensure programs that support urban and rural communities, community and state colleges, as well as our clinical partners to continually improve health care access and quality across Nebraska.

Goal 5.0

Inclusion, Diversity & Belonging

Ensure that UNMC is an exemplary culturally sensitive and inclusive organization in its mission of transforming lives through preeminent education, innovative research, and extraordinary care.

Strategy 5.1

Strengthen UNMC culture to enhance the recruitment, engagement, and mentorship of faculty, students, and staff. Increase retention, recruitment, engagement and mentorship of all faculty, students, and staff by enhancing best practices of engagement across all UNMC and Nebraska Medicine programs and sites.

Strategy 5.2

Develop, and partner with communities to promote enhancement of cultural understanding with those we serve. Enrich the environment of engagement and collaboration in communities served through programs that promote a culture of inclusion based upon the authentic identities of students, residents, staff, faculty and the communities we serve.

Strategy 5.3

Continually evaluate outcomes of Inclusion, Diversity, and Equity (IDE) initiatives. Continue to evaluate ongoing and new opportunities of IDE structures at UNMC at the unit and campus level. Review health professions curricula and accreditation standards to assure IDE content is effectively addressed.

Strategy 5.4

Assure that all students, faculty, and staff are welcome to model their authentic identity.

Assure that all students, faculty, and staff may own and model their authentic identity in a welcoming, collaborative, and inclusive culture at UNMC. Exemplify the recruitment and retention of an engaged university health care workforce.

Strategy 5.5

Mentor local and on-campus champions to lead programs that promote inclusion, diversity, and belonging. Develop additional programs that help eliminate unconscious/implicit bias to distinguish UNMC as an inclusive and diverse organization. Develop and mentor local champions to lead programs that sustain exemplary inclusion in the learning and working environments.

Goal 6.0

Economic Development

Diversify and strengthen the regional and global economic impact of UNMC's educational, research and clinical programs.

Strategy 6.1

Increase intellectual property development, protection and commercialization of UNMC research. Increase the number of new inventions and foster novel intellectual property development programs to ensure that new discoveries can developed into products that have a positive impact on health and health care.

Strategy 6.2

Utilize UNeTech Institute/public-private partnerships to strengthen faculty collaboration.

Expand mutually beneficial and sustainable technology development programs that utilize the UNeTech Institute and public-private partnerships in collaboration with faculty, students, UNeMed, iEXCEL, University of Nebraska campuses, the business community, military, and others.

Strategy 6.3

Identify new capital sources to support our mission to increase regional economic vitality.

Work with community partners to identify early, middle, and late-stage venture capital opportunities to support our technology transfer and commercialization efforts to enhance the quality of life for students, faculty, staff, patients, and visitors, and increase the economic vitality of Nebraska.

Strategy 6.4

Develop partnerships with advanced technology companies and multi-media organizations.

Develop new and sustainable partnerships with advanced technology and multi-media public and private organizations to develop new products that improve the efficiency of clinical care delivery.

Strategy 6.5

Grow and sustain expanded research facilities and services. Grow and sustain research facilities and services to support university-wide researchers and promote external business collaborations in biomedical science education and research that leverage machine learning in research and clinical care.

Strategy 6.6

Diversify UNMC revenues by commercializing market ready technology and services. Expand public-private partnerships, UNMC commercialization structures and other business relationships to enhance UNMC revenues by commercializing marketable technology, services, and resources. Embrace opportunities created in partnership with the Catalyst-Innovation Hub facility.

Organizational Culture

Strengthen faculty, student and employee loyalty, satisfaction, and wellness by enhancing organizational programs and culture.

Strategy 7.1

Make UNMC "THE" preferred working and learning environment. Make UNMC "THE" preferred working and learning environment by implementing programs of belonging, personal growth, career enhancement and leadership development to strengthen employee loyalty, engagement, and satisfaction. Enhance the UNMC climate by promoting high quality faculty/student advising relationships and supervisor/employee interactions. Use data from Climate Surveys, Engagement Surveys, and other sources to develop programs and track outcomes over time.

Strategy 7.2

Enhance and coordinate customer friendly services delivered by UNMC. Enhance and coordinate customer friendly services delivered by UNMC, clinical and campus partners for our faculty, staff, students, alumni, patients, and community partners. This includes the implementation of the full benefit of the NU System Culture Surveys, Information Management Governance Council and other initiatives.

Strategy 7.3

Implement forward thinking professional development programs for faculty and staff.

Implement professional development programs for faculty and staff by focusing on nontraditional "Design Thinking" and "Extraordinary Thinking." Utilize Design Thinking to evaluate and transform education, research, campus operations, and clinical programs processes and outcomes of all UNMC colleges and institutes.

Strategy 7.4

Utilize broad, global, and innovative communication strategies. Utilize broad, global, and innovative communication strategies, including social media Utilize traditional and innovative communication strategies that address the needs of all UNMC constituents.

Strategy 7.5

Reduce individual and organizational risks of UNMC and our business partners. Reduce individual and organizational risks of UNMC and our clinical and business partners by enhancing employee knowledge and accountability of high-reliability processes, procedures, and systems and through establishing a culture of accountability and excellence. Achieve this by using the annual UNMC Risk Assessment and Risk Mitigation Strategies process as examples of means to achieve this outcome.

Strategy 7.6

Make UNMC the healthiest campus in the US to be a student, staff, or faculty member.

Enhance personal and professional wellness through reduction of issues that create burnout in our faculty, students, residents, and staff. Improve work-life integration by considering the needs and roles and responsibilities of employees in determining and offering flexible work site arrangements.

Strategy 7.7

Establish the "Culture of One" for UNMC and our clinical partners. Establish the "Culture of One", one message for UNMC and key clinical partners as accountable high-reliability organizations that focus on the quadruple aim and strive to eliminate all preventable harm.

Strategy 7.8

Celebrate & reward staff, students and faculty who exemplify the iTEACH values.

Acknowledge, celebrate, and reward staff and faculty who exemplify the iTEACH values in the delivery of education, research, and clinical care. Build the iTEACH values into our educational, career development and assessment structures.

Goal 8.0

Organizational Leadership

Ensure exemplary campus-wide organizational leadership and management for planning, program development and implementation of all the UNMC mission-driven strategic goals and initiatives.

Strategy 8.1

Enhance UNMC professional development programs to strengthen leadership performance.

Continually enhance UNMC leadership development programs that increase the effectiveness and diversity of current and future leadership teams and strengthen the performance of current and new faculty and staff leaders in the arenas of educational, administration, mentorship, fiscal, operational, safety, compliance, and management.

Strategy 8.2

Strengthen strategic planning & operations of all UNMC academic & business units.

Strengthen the continuous strategic planning and operations of all UNMC academic and business units by utilizing well-defined institutional goals, strategies, metrics, and a utilization of timely dashboard outcomes reports from all academic and business unit plans.

Strategy 8.3

Implement, enhance, and communicate stakeholder accountability for the UNMC Facilities

Master Plan. Implement, continually enhance, and widely communicate broad stakeholder accountability for the UNMC Facilities Master Plan. These processes should include UNMC updates involving all key stakeholders. Work with the Office of the President to develop, strengthen and communicate broad-based sustainable strategies that enhance the stewardship of public and private resources across educational, research and clinical missions of UNMC.

Strategy 8.6

Engage in succession planning for key leadership roles across UNMC and our clinical partners. Extend UNMC innovative leadership development, mentorship, coaching and other programs for emerging leaders. Formalize succession planning for key leadership positions.

Strategy 8.7

Widely extend innovative leadership development, mentorship and coaching opportunities.

Widely extend UNMC innovative leadership development, mentorship, coaching and other programs for our faculty, staff, students, and other learners.


Strategy 8.8







Annual Economic Impact of the University of Nebraska Medical Center









 In 2021, \$36.76 in economic impact is generated in the Nebraska economy for every \$1 provided by the State of Nebraska's general fund appropriations for UNMC and Nebraska Medicine.



The University of Nebraska **Medical Center (UNMC)**

Founded in 1869 and chartered as the state's first medical college in 1881, the University of Nebraska Medical Center (UNMC) became part of the University of Nebraska in 1902. UNMC trains more health professionals than any other institution in the state. Committed to providing exceptional education, UNMC is dedicated to training the future health care workforce to improve the health of Nebraskans and beyond through its premier educational programs, high-quality patient care, innovative research, and technology.

UNMC creates an environment of diversity, equity, and inclusion for all faculty, staff, and students. UNMC's goal is an inclusive campus environment where every individual feels welcomed, valued, and supported providing training and development opportunities to cultivate the skills needed to effectively engage, communicate, and collaborate with others across differences.

As a major economic engine for the state, UNMC embraces the richness of its diverse community. Nearly half of Nebraska's physicians, dental professionals, bachelor-prepared nurses, and allied health professionals have graduated from UNMC. Underscoring UNMC's commitment to its "five-hundred-mile campus" across Nebraska, the percentage of medical school graduates who practice in rural areas ranks fifth in the nation among all medical schools. Economic Impacts


Instrumental to the state's economic success, UNMC, Nebraska Medicine, and their affiliates¹ are essential to the medical center's operations directly or indirectly impacting residents of Nebraska daily through clinical care services, operational spending, and research.

UNMC, Nebraska Medicine, and affiliates grow Nebraska business volume in two ways:

- Direct expenditures for goods and services by UNMC, employees, students, out-of-state patients, and visitors. This spending supports local businesses, which in turn employ local individuals to sell the goods and provide the services that UNMC/Nebraska Medicine and their affiliates need.
- Indirect spending within Nebraska. The businesses and individuals that receive direct payments from UNMC, Nebraska Medicine, and their affiliates re-spend this money within Nebraska, thus creating the need for more jobs.

The overall economic impact on the state from UNMC, Nebraska Medicine, and affiliates in Nebraska in FY21 totaled \$6.4 billion.

Economic Impacts of UNMC, Nebraska Medicine, and Affiliates








Workforce Impacts

UNMC in FY21 in conjunction with Nebraska Medicine and their affiliates supported 56,050 jobs in the Nebraska economy. These jobs included not only direct employment from UNMC, Nebraska Medicine, and affiliates but also indirect jobs created through the supply chain and equipment vendors, laborers for the construction, contractors, and renovation of facilities. Jobs were created at restaurants, hotels, and retail stores.

Other sectors of the economy impacted include health care (i.e., physician, hospitals, and dental offices); nursing and residential care facilities; real estate establishments; and non-residential commercial construction, restaurants, retail, and wholesale trade businesses. UNMC, Nebraska Medicine, and affiliates also support thousands of jobs statewide in many sectors of the Nebraska economy.

Employment Impacts of UNMC, Nebraska Medicine, and Affiliates






State and Local Tax Impacts

In FY21 UNMC, Nebraska Medicine, and affiliates generated \$220.2 million in state and local tax revenue.

Spending within the state from UNMC, Nebraska Medicine, and their affiliates generate government revenue in the form of sales tax, corporate net income tax, and other business taxes paid by the companies receiving revenue from UNMC, Nebraska Medicine, and their affiliates.

State and Local Tax Impacts of UNMC, Nebraska Medicine, and Affiliates






Alumni Generate Additional Impacts

Business Spin-off Impacts

The total economic impact from the 23 patents issued to researchers at UNMC in FY21 is estimated to boost the Nebraska economy annually by approximately \$200 million over the next 10 years. UNMC reported five startups in FY21:

- Ensign Pharmaceutical Inc.
- 2. Shabri LLC
- 3. Precision Syringes LLC
- 4. Goldenrod Therapeutics
- 5. Advanced Nano Therapies Inc.

These companies are expected to generate an annual economic impact on the state of Nebraska of approximately \$50 million in five years based on national growth standards and create approximately 450 new jobs. All economic impact projections in this section are in addition to the \$1.5 billion operational impacts of the UNMC in FY21.



Study Methodology

About IMPLAN

Tripp Umbach estimated the economic impact of UNMC using IMPLAN (IMpact Analysis for PLANing), an econometric modeling system developed by applied economists at the University of Minnesota and the U.S. Forest Service. The IMPLAN modeling system has been in use since 1979 and is currently used by more than 500 private consulting firms, university research centers, and government agencies. The IMPLAN modeling system combines the U.S. Bureau of Economic Analysis' Input-Output Benchmarks with other data to construct quantitative models of trade flow relationships between businesses and between businesses and final consumers. From this data, one can examine the effects of a change in one or several economic activities to predict its effect on a specific state, regional, or local economy (impact analysis). The IMPLAN input-output accounts capture all monetary market transactions for consumption in each time period. The IMPLAN input-output accounts are based on industry survey data collected periodically by the U.S BEA and follow a balanced account format recommended by the United Nations.



Study Methodology

IMPLAN's Regional Economic Accounts and the Social Accounting Matrices were used to construct state-level multipliers, which describe the response of the state economy to a change in demand or production because of the activities and expenditures of UNMC. Each industry that produces goods or services generates demand for other goods and services, and this demand is multiplied through a particular economy until it dissipates through "leakage" to economies outside the specified area. IMPLAN models discern and calculate leakage from local, regional, and state economic areas based on workforce configuration, the inputs required by specific types of businesses, and the availability of both inputs in the economic area. Consequently, economic impacts that accrue to other regions or states because of a change in demand are not counted as impacts within the economic area.

The model accounts for substitution and displacement effects by deflating industryspecific multipliers to levels well below those recommended by the U.S. Bureau of Economic Analysis. In addition, multipliers are applied only to personal disposable income to obtain a more realistic estimate of the multiplier effects from increased demand. Importantly, IMPLAN's Regional Economic Accounts exclude imports to an economic area, so the calculation of economic impacts identifies only those impacts specific to the economic impact area, in this case, the state of Nebraska. IMPLAN calculates this distinction by applying Regional Purchase Coefficients (RPC) to predict regional purchases based on an economic area's particular characteristics. The RPC represents the proportion of goods and services that will be purchased regionally under normal circumstances, based on the area's economic characteristics described in terms of actual trade flows within the area.
