

Vice Chancellor for Academic Affairs
Varner Educator Laureate Award

The Varner Educator Laureate Award is the highest recognition given by UNMC and, as such, can only be awarded one time to the same individual. The award recognizes an individual with sustained achievement in education who has significantly improved the UNMC learning environment through the provision of outstanding educational experiences.

ELIGIBLE CANDIDATES

- **Rank:** All full-time or part-time UNMC faculty members in an educational role are eligible except UNMC Deans (Associate Deans are eligible), Institute Directors, Hospital CEO, Vice Chancellors, or Chancellor
- **Experience:** UNMC faculty member for 5 or more years (from award submission deadline)
- Past recipients of this award are not eligible to receive this award again

AWARD CRITERIA

- Development of innovative curricular and instructional materials (e.g., development of written/electronic course materials, participation in departmental, and/or campus curriculum development) used by others internal and external to UNMC
- Use and promotion of highly creative and innovative teaching methods, educational technologies, and assessment methods
- Dissemination of educational innovations as scholarly work in education (including grant awards, as well as presentations at national education meetings and publications)
- Creation of high-quality didactic and experiential learning environment inside and outside the classroom
- Evidence of facilitation of student learning based on receipt of outstanding student evaluations and competency-based learner assessments
- Leading the development or major revision of a national, department, or college curriculum
- Enhances UNMC learning through innovative design of instructional space and the learning environment
- Mentoring of other learners and educators at UNMC
- Receipt of university or national teaching awards

Vice Chancellor for Academic Affairs
Emerging Educator Award

The Emerging Educator Award recognizes an emerging health science educator who demonstrates excellence, dedication, and perseverance in teaching and education early in their career. The focus will be on work done while at UNMC.

ELIGIBLE CANDIDATES

- **Rank:** Open to all full-time or part-time UNMC faculty members at the rank of instructor or assistant professor in an educational role. UNMC Deans, Institute Directors, Hospital CEO, Vice Chancellors, and the Chancellor are not eligible.
- **Experience:** Faculty must have served at UNMC for at least 1 year, but less than 5 years as of the award submission deadline.
 - *Only faculty members with less than 10 years of total faculty experience, including time at previous institutions, are eligible. The award committee will only consider experience and endeavors while the candidate has been a faculty member at UNMC*
- Previous recipients are not eligible for reconsideration for this award.

AWARD CRITERIA

- Demonstrated excellence in health science education at the local or regional level as evidenced by active participation in educational committees, presentations, workshops, or similar professional activities
- Evidence of teaching innovation in the classroom or clinical setting demonstrated using creative instructional methods, use of new technologies, or novel practical exercises in the clinical or classroom setting
- Effective mentoring of students or other learners in the classroom or clinical setting characterized by through establishing strong relationships that foster mentees' academic and professional development
- Recognition of teaching excellence by peers or students as evidenced by including endorsements, award nominations, or honors received from colleagues or learners
- Development of comprehensive, content-aligned curricular materials aligning with educational standards and/or collaborative efforts with colleagues on interprofessional resources
- Use/dissemination of educational materials at the local or regional level through presentations, workshops, or peer-reviewed publications

Vice Chancellor for Academic Affairs

Excellence in Educational Service Award

The Excellence in Educational Service Award recognizes a UNMC volunteer, emeritus, or adjunct faculty member who exemplifies the spirit of outstanding teaching and whose contributions are significant and lasting to the advancement of health care learners, health care education, or health care professions. Focus will be on work done while at UNMC.

ELIGIBLE CANDIDATES

- **Rank:** All UNMC volunteer, emeritus, or adjunct faculty members
- **Experience:** UNMC volunteer, emeritus, or adjunct faculty member for 2 years or more (from award submission deadline)
- Past recipients of this award are re-eligible in 5 years

AWARD CRITERIA

- Dedicated service to educating health professions learners
- Provides high-quality learning environment inside or outside the classroom
- Excellence in teaching based on informal or formal evaluations, feedback, and individual reputation

NOMINATION MATERIALS

Nominators for the Excellence in Educational Service Award are responsible for submitting all nomination materials

2. Nominator Statement

Nominators will **receive a link** to complete their nominator statement within Microsoft Forms. Nominator statement must emphasize evidence of award criteria.

3. Letters of Support

Nominator's **submit at least two letters** of support that **specifically address the award criteria**. A maximum of three letters are permitted.

Letters of support may be received from learners (students, residents, and fellows), staff, or faculty members at UNMC or collaborators from other institutions. A letter from a supervisor or candidate's chair may be submitted but is not required.

NOTE: It is recommended that at least one letter be from a learner.

Vice Chancellor for Academic Affairs

Innovative Practices in Education Award

The Innovative Practices in Education Award recognizes an individual or team that demonstrates ingenuity, courage, and creativity in teaching, including innovations in use of educational technology, experiential learning, adoption of simulation and/or creative use of the classroom. Focus will be on work done while at UNMC.

ELIGIBLE CANDIDATES

- **Rank:** All full-time or part-time UNMC faculty members in an educational role are eligible except UNMC Deans (Associate Deans are eligible), Institute Directors, Hospital CEO, Vice Chancellors, or Chancellor; if you are applying as a team, all individuals must be UNMC faculty members
- **Experience:** UNMC faculty member for 2 or more years (from award submission deadline)
- Past recipients of this award will be re-eligible in 5 years

AWARD CRITERIA

- Use of innovative teaching methods to create a high-quality learning environment inside and outside the classroom
- Development of new innovations for learners (programs, curriculum, instructional material)
- Development of curricular materials
- Use/dissemination of educational innovation as scholarship (presentations, publications) at local, regional, or national level
- Teaching unique education techniques to others
- Activity has educational impact as supported by assessment and evaluation

Vice Chancellor for Academic Affairs

Inspirational Mentor of Educators Award

The Inspirational Mentor of Educators Award recognizes an individual who has mentored junior faculty or trainees in developing as health professions educators. This mentorship may take the form of individual mentoring, or developing and implementing programs or resources targeted to improve health professions educators at the local, regional, or national level. The focus of this mentoring award is on developing future health professions educators at UNMC.

ELIGIBLE CANDIDATES

- **Rank:** All full-time or part-time UNMC faculty members in an educational role are eligible except UNMC Deans (Associate Deans are eligible), Institute Directors, Hospital CEO, Vice Chancellors, or Chancellor
- **Experience:** UNMC faculty member for 5 or more years (from award submission deadline)
- Past recipients of this award will be re-eligible in 5 years

AWARD CRITERIA

- Providing formal mentoring to junior faculty and/or trainees in developing as health professions educators on a local, regional, or national level
- Developing mentoring activities or processes for use by UNMC educators or other educational organizations regionally or nationally, to improve health professions education
- Record of outstanding mentoring of health professions educators as measured by the documented success/demonstrated outcomes of their mentees as educators
- Conducting research, publishing, or presenting at professional conferences on how to improve the mentoring of health professions educators
- Leading or participating on grants for the purpose of developing trainees as health professions educators
- Recognition as an outstanding mentor of health professions educators in local, regional, or national mentoring awards

Interprofessional Education Scholar Award

The Interprofessional Education Scholar Award recognizes an individual or team who has demonstrated excellence in interprofessional education. This includes teaching in an interprofessional learning environment, disseminating the results and best practices of interprofessional education, and contributing locally, regionally, or nationally to the advancement of interprofessional education. Focus will be on work done while at UNMC.

ELIGIBLE CANDIDATES

- **Rank:** All full-time or part-time UNMC faculty members in an educational role are eligible except UNMC Deans (Associate Deans are eligible), Institute Directors, Hospital CEO, Vice Chancellors, or Chancellor; if you are applying as a team, all individuals must be UNMC faculty members
- **Experience:** UNMC faculty member for 2 or more years (from award submission deadline)
- Past recipients of this award will be re-eligible in 5 years

AWARD CRITERIA

- Demonstration and modeling highly collaborative interactions with colleagues from other educational disciplines as defined by the four IPEC Competencies (<https://www.ipecollaborative.org/ipec-core-competencies>)
- Use of creative interprofessional teaching methods
- Development of interprofessional curriculum and instructional materials used locally, regionally, or nationally
- Mentoring of other interprofessional educators at UNMC
- Receipt of local, regional, or national interprofessional teaching awards
- Peer-reviewed publications or presentations in interprofessional education
- Leadership roles in national organizations supporting interprofessional education
- Evidence of grant funding in the area of interprofessional education

Vice Chancellor for Academic Affairs

Scholar in Education Research Award

The Scholar in Education Research Award recognizes an individual who has advanced the science of teaching and learning through research of educational pedagogy. This includes receiving funding for original research in the areas of teaching/ learning strategies, learning outcomes, and best practices in education. Significant contributions are demonstrated through peer reviewed publications, grants, and participation on the local, regional, or national level in developing educational scholarship. Focus will be on work done while at UNMC.

ELIGIBLE CANDIDATES

- **Rank:** All full-time or part-time UNMC faculty members in an educational role are eligible except UNMC Deans (Associate Deans are eligible), Institute Directors, Hospital CEO, Vice Chancellors, or Chancellor
- **Experience:** UNMC faculty member for 2 or more years (from award submission deadline)
- Past recipients of this award will be re-eligible in 5 years

AWARD CRITERIA

- Evidence of ongoing education research emphasis
- Dissemination of scholarly work related to education research through peer-reviewed publications, conference presentations, and proceedings
- Development of evidence based educational materials used locally, regionally, or nationally (higher weight given to peer reviewed materials) based on educational research findings
- Funding received to support education research

Vice Chancellor for Academic Affairs

Visionary Leadership in Education Award

The Visionary Leadership in Education Award recognizes an individual who has demonstrated the ability to skillfully establish or administer an educational initiative or role at UNMC or nationally. Focus will be on work done while at UNMC.

ELIGIBLE CANDIDATES

- **Rank:** All full-time or part-time UNMC faculty members in an educational role are eligible except UNMC Deans (Associate Deans are eligible), Institute Directors, Hospital CEO, Vice Chancellors, or Chancellor
- **Experience:** UNMC faculty member for 2 or more years (from award submission deadline)
- Past recipients of this award are re-eligible in 5 years

AWARD CRITERIA

- Editor/author of a major course textbook, journal, or publication utilized at UNMC +/- other educational institutions
- Development of new and innovative teaching and learning programs in use at UNMC +/- other educational institutions
- Multiple presentations at regional, national, or international educational meetings primarily while on faculty at UNMC
- Development of new educational programs (e.g., Master's degree, certificate program, fellowship) at UNMC
- Leading a revision of educational materials or teaching techniques and styles at UNMC to improve learner education
- Receipt of local, regional, or national teaching awards primarily while on faculty at UNMC
- Leading a major educational unit, program, or initiative at UNMC
- Leads the development of improved educational policies and procedures at UNMC
