**Submission Requirements:** Submissions must go through the electronic Protocol Review and Monitoring System (ePRMS) module in the Clinical Trial Management Systems (CTMS). Any personnel requiring ePRMS access must complete training to enable entry into the ePRMS module system in CTMS. The PRMS Office and SRC are not responsible for delays in submission reviews if ePRMS training is pending.

**General Submission Guidelines:** It remains the responsibility of the PI to be aware of SRC deadlines if a submission requires review at the next meeting. Submissions that do not meet the submission deadline will only be reviewed at the next full committee meeting if the SRC Chair or Vice-Chair approves a formal request by the PI outlining the rationale for review at the next full committee meeting. The SRC Coordinator screens all submissions for completeness and accuracy. Only submissions that meet the minimum requirements may be accepted for review at the next full committee meeting at the discretion of the PRMS Administrator.

**Note:** All other trials, such as National Cooperative Groups (NCG), Multi-Institutional (Multi-Inst), and other Externally Peer Reviewed (EPR) submissions receive an expedited review by the SRC; therefore, the above deadlines do not apply.
