



# Advanced Standing Dental Program (D.D.S.)

## Program FAQs

### What is the purpose of the UNMC Advanced Standing Dental Program?

The program allows dentists educated outside of the United States the opportunity to earn a Doctor of Dental Surgery (D.D.S.) degree. Upon successful completion of the 29-month program, students are eligible to apply for licensing to practice dentistry in the United States.

### Who is the program for?

The Advanced Standing Dental Program has been developed for individuals who have completed the equivalent of a D.M.D. or D.D.S. program in a non-U.S. or Canadian accredited dental school. It is intended for individuals who are interested in pursuing a dental career in the U.S. or are interested in returning to their country with additional

skills acquired in a U.S. accredited D.D.S. program. The program is open to U.S. citizens and permanent residents.

### What do students learn?

Advanced Standing students are fully integrated into the second-year, second-semester curriculum which incorporates preclinical general dentistry didactic and laboratory courses. In addition, this curriculum includes a course specially designed for Advanced Standing students to ensure a seamless integration into the clinic and prepare for third- and fourth- year didactic courses.

This curricular concept prepares students with the foundation for providing comprehensive patient care in all facets of general dentistry and understanding of treatment protocols, materials and techniques.

## Hands-On Learning Experiences

### Work in teams to provide patient care

Our highly effective clinical model closely resembles providing comprehensive care within a private practice. Students are assigned to teams that provide patients with all the care they need. This clinic model promotes teamwork and helps students build relationships with their patients.

### Use virtual reality to build clinical skills

In our innovative Clinical and Virtual Simulation Laboratory, students build their clinical skills through clinical simulations and using virtual reality dental trainers which use the most advanced simulation technology.

### Build digital dentistry skills

In our new Digital Design Studio, students have access to the latest CAD/CAM technology for designing dentures and restorations and an equipment studio with 3D printers and milling machines.



### Lead oral health research projects

## Application Procedure

Applicants must apply through the ADEA Centralized Application for Advanced Placement for International Dentists (CAAPID) at:

[adea.org.CAAPIDapp](http://adea.org.CAAPIDapp)

*The UNMC College of Dentistry will accept U.S. citizens and U.S. permanent residents. We are committed to complying with the requirements of the Americans with Disabilities Act.*

### English Language Proficiency

- Must be proficient in speaking and reading English.
- All non-native English speaking applicants must take the Test of English as a Foreign Language (TOEFL). Applicants must score a minimum of 95 on the internet-based test, 550 on the paper based-test, or 213 on the computer-based test.
- The ETS Institution Code for UNMC is 6896.
- Only scores from TOEFL exams taken after October 1, 2023 will be accepted. Original TOEFL scores must be submitted from TOEFL directly to ADEA CAAPID. UNMC College of Dentistry does not accept TOEFL BEST score reporting.

### National Board Dental Examination Requirements

- Applicants must pass NBDE Parts I and II or the INBDE.
- If an interview is offered, submission of official National Board Dental Scores will be requested.

### Letters of Evaluations

- Three letters of evaluation are required; one must come from a former faculty member and two should come from former mentors or employers who can attest to applicant's character, conduct and professional ability.
- Letters must be less than 1 year old, written in English, and signed by the letter writer on official letterhead with contact information.
- Writers must submit letters of evaluation directly to ADEA CAAPID.

### Transcripts and Evaluations

- Applicant must submit a detailed evaluation by ECE or WES to ADEA CAAPID.
- If chosen for an interview, the applicant must submit the official transcripts and degree certificates from their dental school directly to the program. This includes any additional educational programs following dental school.

### Application Fees

- \$250 application fee (separate from the ADEA CAAPID application fee). Interview fee is \$500 and includes a psychomotor skills assessment.
- Admitted and accepted students must pay a non-refundable tuition deposit.
