### Applications for H-4 Visa status is adjudicated together with H-1b applications

H-4 Visa status is for dependents of H-1b employees. Prior to 2019, the U.S. Citizenship and Immigration Services (USCIS) adjudicated applications for a change of visa status to H-4 or for extending H-4 status together with H-1b applications submitted by the H-1b spouse's employer. After March 2019, adjudication times for applications for H-4 status ballooned to one year or more. The USCIS has now returned to processing applications for H-4 status together with the accompanying H-1b applications and will also simultaneously process I-765 applications for those in H-4 status that are eligible for an H-4 work permit known as an Employment Authorization Document (EAD).

# Department of State implements visa retrogression for I-485 applications with EB-1b category

Earlier in 2023, the Department of State implemented visa retrogression for citizens of India and China in the EB-1b "outstanding researcher" category. According to the March 2023 Visa Bulletin, the filing dates for both India and China is June 1, 2022. This means that employees from these two countries can only submit I-485 applications if the priority date on their employer's I-140 approval is before June 1, 2022. This marks the first time in three years that there is a backlog for this category.

With an approved I-140 application, employers may extend H-1b sponsorship past the sixyear limit and H-4 spouses of H-1b employees are eligible to apply for a work permit.
