### Description of partner organization's priority opportunities (APEx activities):

Students will contribute to analysis and reporting of the Nutrition Environment Measures Survey (NEMS), which has been conducted in 2015, 2018, and 2024. A summary report of the 2024 data has already been created. The goal of the project is to take a deeper dive into the existing data and generate findings to inform potential interventions.

Activities may include:

- Conducting data analysis on 2024 data to identify key findings to inform next steps
- Compiling and comparing data across multiple survey years
- Conducting qualitative data analysis on NEMS perceptions (interview data on healthy food access, cooking in the home, access to appliances, etc.)
- Developing a secondary analysis report to build on work completed in Summer 2024
- Creating a short presentation of findings for the Creighton REACH Program and collaborating with community health workers to apply insights from the data
- Identifying evidence-based practices based on findings related to healthy food promotion and access
- Preparing a final presentation of findings for DCHD and REACH partners

**Timeframe of proposed activities:** Spring 2026, with potential option to integrate data analysis into a capstone project.

## Benefit of proposed activities to partner organization:

- Provides deeper analysis and actionable next steps from existing NEMS data
- Helps identify key trends and gaps to guide strategies promoting healthy foods and food access
- Supports ongoing partnership with Creighton REACH and community health workers
- Strengthens evidence base for future interventions and programs

### **Benefit of proposed activities to the student:**

- Hands-on experience with epidemiologic and biostatistical data analysis
- Opportunity to present findings to public health partners and community stakeholders
- Skill-building in program evaluation, research translation, and public health communication
- Exposure to applied research that informs community-level action
- Potential to extend into a capstone project

### Skill sets of students requested:

- Basic data analysis skills required
- Strong written and oral communication skills
- Ability to synthesize findings and translate data into practical recommendations
- Interest in chronic disease prevention, nutrition, and health equity
