ABSTRACT SUBMISSION:

Abstract for conference program (100-word maximum)

Project Description (300-word maximum)

- Significance of the project to health administration
- Impact areas on health administration, operations management, policy, or processes.
- Innovations, best practices, or quality initiatives welcome.

Presentation format (e.g., poster, with the manuscript of the completed project, etc.)
