2:15 pm – 3:00 pm	Wastewater Surveillance in Nebraska: SARS-CoV-2 and Beyond The COVID-19 pandemic has shown that wastewater surveillance can provide critical information on the abundance and extent of an outbreak in a given region. In 2021, Nebraska setup a statewide wastewater surveillance system to monitor SARS-CoV-2 abundance. Monitoring wastewater has yielded valuable data for improving public health in Nebraska, and in the future it will expand to include targets other than SARS-CoV-2.
