

- Interest rates on Federal Direct Loans are set according to a formula based on an auction of 10 year Treasury notes under section 455(b)(7) of the Higher Education Act (HEA).
- On May 10, 2023, the Treasury Department held a 10-year Treasury note auction that resulted in a high yield of 3.448%. Each rate is the sum of this index plus an add-on that varies depending on the type of loan and whether the borrower is an undergraduate or graduate/professional student.
