## 2021-2022 Financial Aid Reevaluation Request

The 2021-2022 Free Application for Federal Student Aid (FAFSA) must be filed using 2019 tax information. However, the UNMC Office of Financial Aid can reevaluate FAFSAs by request based on changes in a family's financial situation. These are processed on a case-by-case basis in order of receipt and completion, and the final decision is made by the Financial Aid Office.

## **Important Considerations**

- The last day to submit a reevaluation request is April 7, 2022.
- After November 1, 2021 the 2021 Federal Tax Return and supporting documents will be required.
- The student must be enrolled or intend to enroll for the term for which consideration is requested.
- A change in your financial situation does not guarantee that a change in the student's aid package will be made.
- UNMC will not consider requests from parents or students who voluntarily experience a reduction in income to return to school.
- Allow up to 4 weeks for processing (the more prompt you are with follow up questions, the quicker the processing).
