## 2023-2024 Special Circumstances Request

The 2023-2024 Free Application for Federal Student Aid (FAFSA) must be filed using 2021 tax information. However, the UNMC Office of Financial Aid can reevaluate FAFSAs by request based on changes in a family's financial situation.

## **Important Considerations**

- The last day to submit a reevaluation request is April 5, 2024.
- After November 1, 2023 the 2023 Federal Tax Return and supporting documents will be required.
- The student must be enrolled or intend to enroll for the term for which consideration is requested.
- A change in your financial situation does not guarantee that a change in the student's aid package will be made.
- UNMC will not consider requests from parents or students who voluntarily experience a reduction in income to return to school.
- Allow up to 4 weeks for processing and the final decision is made by the Office of Financial Aid.
